Enacts new GS 135-4(gg) which provides for purchase of creditable service under the Teachers' and State Employees Retirement System for periods of employment with the University of North Carolina during which the member participating in the Optional Retirement Program. Enacts technical changes to statutes governing the state retirement systems. Effective July 1, 2007.

H 777. RETIREMENT TECHNICAL CHANGES. Filed 3/14/07. House committee substitute makes the following changes to 1st edition. Amends GS 135-3(8)c. and GS 128-24(5)c. to provide that when the reemployment earnings exceed the amount as provided for in the statute in the month of December, the retirement allowance is not suspended.

H 777. RETIREMENT TECHNICAL CHANGES. Filed 3/14/07. House committee substitute makes the following changes to 2nd edition. Further amends GS 135-5(g1) [Teachers and State Employees Retirement System (TSERS)] and 128-27(g1) (Local Governmental Employees' Retirement System) to modify the proposed definition of *accumulated contributions* and to provide that the definition applies only to the first three paragraphs of each subsection. Deletes the proposed amendment to GS 135-105(c), which would have provided a minimum short-term disability benefit of \$10 a month under the NC Disability Income Plan. Makes technical changes. Amends GS 135-4(r)(3) to make additional beneficiaries of long-term disability under TSERS eligible to purchase creditable service. Amends GS 135-5 to provide eligibility under the TSERS Death Benefit Plan and Survivor's Alternate Benefit for certain recipients of short-term disability benefits.
