**H 786. LEO PROVIDE INFO TO DA FOR DISCOVERY.** Filed 3/14/07. *TO ENSURE DISTRICT ATTORNEYS RECEIVE ALL NECESSARY INFORMATION FROM LAW ENFORCEMENT AGENCIES AS RECOMMENDED BY THE HOUSE INTERIM STUDY COMMITTEE ON CAPITAL PUNISHMENT.*

Enacts new GS 15A-903(c) to require law enforcement agencies to make available to the state complete files related to the investigation of crimes committed or to the prosecution of a defendant to comply with rules governing disclosure of evidence by the state. Effective December 1, 2007, and applicable to cases where trial date is on or after that date.

**H 786. LEO PROVIDE INFO TO DA FOR DISCOVERY.** Filed 3/14/07. House amendment makes the following changes to 1st edition. Amends new GS 15A-903(c) to clarify that a law enforcement agency must make available to the state a complete copy of the complete files.

**H 786. LEO PROVIDE INFO TO DA FOR DISCOVERY.** Filed 3/14/07. Senate committee substitute makes the following changes to 2nd edition. Modifies proposed new GS 15A-903(c) to (1) provide that a law enforcement *or prosecutorial* agency (was, law enforcement agency) is to make available a complete copy of the files related to the investigation of the crimes or prosecution of the defendant and (2) specify that the information is to be made available upon request by the state. Provides that nothing in the act is to be construed to annul or repeal any judicial rulings or decisions made before the effective date (December 1, 2007) of the act. Specifies that prosecutions for offenses committed before the effective date of the act are not abated or affected by the act, and statutes that would otherwise be applicable but for the act remain applicable to those prosecutions.
