H 802. CONTRACT POWER/DEPARTMENT OF TRANSPORTATION.-AB. Filed 3/14/97. *TO PROVIDE THE DEPARTMENT OF TRANSPORTATION CONTRACTING AUTHORITY TO PROVIDE FOR TRANSPORTATION INFRASTRUCTURE AND LITTER REMOVAL FROM STATE RIGHTS-OF-WAY.*

H 802. CONTRACT POWER/DEPARTMENT OF TRANSPORTATION. Filed 3/14/97. *TO PROVIDE THE DEPARTMENT OF TRANSPORTATION CONTRACTING AUTHORITY TO PROVIDE FOR TRANSPORTATION INFRASTRUCTURE AND LITTER REMOVAL FROM STATE RIGHTS-OF-WAY.* Amends GS 136-28.1 to authorize the Department of Transportation enter into up to two contracts for the removal of litter from state right-of-ways. Establishes the guidelines for selecting firms and acknowledging sponsors of the adopt a highway program. Makes conforming and technical changes to GS 136-18.

H 802. CONTRACT POWER/DEPARTMENT OF TRANSPORTATION. Filed 3/14/07. House committee substitute makes the following changes to 1st edition. Amends GS 136-18 to provide that priority for entering into partnership agreements for financing costs is given to highways, roads, streets, and bridges. Requires the Department of Transportation (DOT) to report to chairs of various legislative committees at the time that the DOT notifies the Board of Transportation of any proposed agreement. Makes conforming changes to GS 143B-350(f)(12a). Modifies proposed GS 136-28.1(l) to refer to the contracts as *pilot contracts*. Also removes the provision allowing DOT to issue guidelines necessary to administer the program.

H 802. CONTRACT POWER/DEPARTMENT OF TRANSPORTATION. Filed 3/14/07. Senate amendment makes the following changes to 2nd edition. Rewrites the title of act as *AN ACT TO PROVIDE THE DEPARTMENT OF TRANSPORTATION CONTRACTING AUTHORITY TO PROVIDE FOR TRANSPORTATION INFRASTRUCTURE, LITTER REMOVAL FROM STATE RIGHTS-OF-WAY, AND TRAVEL INFORMATION AT STATE OWNED REST AREAS*. Enacts G.S. 136.28-1(m) authorizing the Department of Transportation (DOT) to enter into as many as two pilot contracts for public-private participation in providing real-time traveler information at state-owned rest areas and providing that selection of firms to perform this work will be made using a best value procurement process. Provides for recognition of sponsors in the program and for use of revenues generated pursuant to a contract. Authorizes the DOT to issue necessary guidelines, rules, and policies to administer a pilot program under the subsection.
