**H 810. CLARIFY ANIMAL WASTE TECH. SPECIALIST REQ.** Filed 3/14/07. *TO CLARIFY THE TRAINING AND QUALIFICATION REQUIREMENTS APPLICABLE TO ANIMAL WASTE MANAGEMENT TECHNICAL SPECIALISTS IN THE PROVISION OF SERVICES RELATED TO THE DEVELOPMENT, IMPLEMENTATION, OR OPERATION OF AN ANIMAL WASTE MANAGEMENT PLAN OR ANIMAL WASTE MANAGEMENT SYSTEM, AS RECOMMENDED BY THE ENVIRONMENTAL REVIEW COMMISSION.*

Amends GS 89C-25 in the Engineering and Land Surveying Act to exclude county employees and employees of Soil and Water Conservation Districts involved in planning, designing, or implementing best management practices on agricultural lands.

**H 810. CLARIFY/EXTEND ANIMAL WASTE MGT. PROVISIONS (NEW).** Filed 3/14/07. Senate committee substitute makes the following changes to 1st edition. Amends Section 15.4(a) of SL 1997-443, as amended, to push back the end date of the pilot program for the annual inspections of animal operations from September 1, 2007, to September 1, 2009. Amends GS 143-215.6A, GS 143-215.6B, and GS 143-215.6C in Part 1 of Article 21 of GS Chapter 143 to provide that the enforcement provisions (civil penalties, criminal penalties, and injunctive relief) also apply to Part 1A (animal waste management systems).
