**H 821. AMEND ENVIRONMENTAL REPORTING REQS. 2007.** Filed 3/14/07. *TO AMEND OR REPEAL VARIOUS ENVIRONMENTAL REPORTING REQUIREMENTS, AS RECOMMENDED BY THE ENVIRONMENTAL REVIEW COMMISSION.*

Amends GS 77-98 to require the Roanoke River Basin Bi-State Commission's annual report to be submitted on or before October 1 of each year. Amends GS 106-744 to add the Environmental Review Commission to those commissions and committees to which the Agricultural Development and Farmland Preservation Trust Fund Advisory Committee must report. Amends GS 130A-310.57 to require the Department of Environment and Natural Resources to submit an annual report to the Environmental Review Commission on the mercury minimization plan (was, publish an annual report).

**H 821. AMEND ENVIRONMENTAL REPORTING REQS. 2007.** Filed 3/14/07. House committee substitute makes the following changes to 1st edition. Amends GS 130A-294.1 to set an October 1 deadline for the Department of Environment and Natural Resources to submit its annual report on the cost of the hazardous waste management program. Removes proposed amendments to GS 130A-310.57 regarding reporting on the mercury minimization plan.

**H 821. SPECIFY OUT-OF-STATE AREAS FOR IBT NOTICE (NEW).** Filed 3/14/07. Senate committee substitute deletes all provisions of the 2nd edition and replaces it with *AN ACT TO SPECIFY THOSE AREAS OUTSIDE OF THE STATE OF NORTH CAROLINA IN WHICH NOTICES RELATED TO A PROPOSED INTERBASIN TRANSFER OF WATER SHALL BE GIVEN AND TO PROVIDE FOR A STUDY BY THE ENVIRONMENTAL REVIEW COMMISSION OF THE DELINEATION OF MAJOR RIVER BASINS AND SUB-BASINS WITHIN THIS STATE AS A PART OF THE ON-GOING STUDY OF THE ALLOCATION OF WATER RESOURCES BY THE COMMISSION.* Amends GS 143-215.22L(c) to require notice of a proposed interbasin transfer of water (IBT) (1) by a newspaper in general circulation and (2) by first-class or electronic mail to certain other entities, located within specific cities and counties in other states that are located in whole or in part of the surface drainage basin area of the source river, which also falls within one of 75 eight-digit cataloging units, organized by the US Geologic Survey. Also requires mail notification to entities in cities and counties in other states that are located in whole or in part in the receiving river basin. Makes conforming changes.

Requires that the Environmental Review Commission study the delineation of major river basins and sub-basins within the state as part of its study on the allocation of water resources, pursuant to Section 1 of SL 2007-518, as amended, and report its findings accordingly. Specifies that the study must consider whether the definition of *river basin* set forth in GS 143-215.22G and the accompanying map entitled, "Major River Basins and Sub-basins in North Carolina," filed in the Office of the Secretary of State on April 16, 1991, should be revised.

SPECIFY OUT-OF-STATE AREAS FOR INTERBASIN TRANSFER NOTICE.** *AN ACT TO SPECIFY THOSE AREAS OUTSIDE OF THE STATE OF NORTH CAROLINA IN WHICH NOTICES RELATED TO A PROPOSED INTERBASIN TRANSFER OF WATER SHALL BE GIVEN AND TO PROVIDE FOR A STUDY BY THE ENVIRONMENTAL REVIEW COMMISSION OF THE DELINEATION OF MAJOR RIVER BASINS AND SUBBASINS WITHIN THIS STATE AS A PART OF THE ONGOING STUDY OF THE ALLOCATION OF WATER RESOURCES BY THE COMMISSION.* Summarized in *Daily Bulletin* 7/1/08. Enacted July 28, 2008. Effective July 28, 2008.
