H 943. UPDATING OF JURY LIST. Filed 3/20/07. TO REQUIRE THE REGISTER OF DEEDS IN EACH COUNTY TO ASSIST THE JURY COMMISSION IN UPDATING ITS LIST OF PROSPECTIVE JURORS BY PROVIDING A LIST OF RESIDENTS OF THE COUNTY WHO HAVE DIED RECENTLY.

Amends GS 9-2, directing the jury commission to remove the names of those in the county who are recently deceased from the list of prospective jurors. Enacts new GS 161-32 directing each county's register of deeds to provide the county's jury commission with a list of all of the county's residents that have died in the two years before July 1 of each odd numbered year. Effective July 1, 2007.

H 943. UPDATING OF JURY LIST. Filed 3/20/07. House committee substitute makes the following changes to 1st edition. Deletes proposed new GS 161-32 (register of deeds to provide list of deceased residents) and instead enacts new GS 130A-121 requiring the State Registrar to provide each county's jury commission with a list of recently deceased residents of the county at least every two years. Amends GS 20-43.4 (current list of licensed drivers to be provided to jury commissions) to require the Division of Motor Vehicles to exclude from the list names for which the driver's license has been expired for at least eight years. Amends GS 163-82.11(e) to require the State Board of Elections to exclude from the list of registered voters any voter who has been inactive for at least four years. Changes the title to *TO REQUIRE THE STATE REGISTRAR TO ASSIST COUNTY JURY COMMISSIONS IN UPDATING THEIR LISTS OF PROSPECTIVE JURORS BY PROVIDING A LIST OF RESIDENTS OF EACH COUNTY WHO HAVE DIED RECENTLY; AND TO EXCLUDE FROM THE LISTS PROVIDED BY THE COMMISSIONER OF MOTOR VEHICLES TO COUNTY JURY COMMISSIONS THE NAMES OF PERSONS WHOSE DRIVERS LICENSES HAVE BEEN EXPIRED FOR AT LEAST EIGHT YEARS AND WHO HAVE BEEN INACTIVE VOTERS FOR AT LEAST FOUR YEARS.*

H 943. UPDATING OF JURY LIST. Filed 3/20/07. Senate committee substitute makes the following changes to 2nd edition. Enacts new GS 130A-121(b) to require the State Registrar to provide to the Division of Motor Vehicles (DMV) the same list the Registrar provides to each county's jury commission under subsection (a) of the proposed statute. Modifies proposed amendments to GS 20-43.4 (current list of licensed drivers to be provided to jury commissions) to (1) add Social Security numbers to the information that DMV must provide and (2) require DMV to exclude from the list names of deceased residents. Modifies proposed amendments to GS 163-82.11(e) to require the State Board of Elections to exclude from the list it provides of registered voters those voters who have been inactive for at least eight (was, four) years. Changes the effective date from July 1, 2007, to October 1, 2007. Modifies the title and makes technical and conforming changes.

Enacts GS 20-7(b2)(5) allowing the Division of Motor Vehicles to disclose social security numbers to each county jury commission for the purpose of verifying the identity of deceased persons whose names should be removed from jury lists.
