**H 986. BUTNER INCORPORATION (=S 1316).** Filed 3/22/07. *TO INCORPORATE THE TOWN OF BUTNER, TO TRANSFER CERTAIN ASSETS PREVIOUSLY HELD BY THE STATE OF NORTH CAROLINA FOR THE TOWN OF BUTNER TO THE NEWLY INCORPORATED TOWN OF BUTNER, AND TO MAKE CONFORMING CHANGES TO PUBLIC LAWS AFFECTING THE BUTNER RESERVATION.*

**H 986. BUTNER INCORPORATION.** Filed 3/22/07. House committee substitute makes the following changes to 1st edition. Updates the Town of Butner's Charter's reference to the map showing the boundaries of the Town of Butner (town) and the town's extraterritorial jurisdiction. Adds sections on annexation restrictions as to Creedmoor and Durham. Adds the names of the assigned temporary officers. Changes the procedure regarding the Mayor Pro Tem. Removes the provision allowing the town to adopt a budget ordinance for 2006-07 without following the timetable in the Local Government Budget and Fiscal Control Act. Adds a provision to the charter providing that the town is considered to have been incorporated on June 30, 2007, for the purposes of allocation of state and local shared revenues for the 2007-08 fiscal year. Requires the Governor to convey to the town specified personal and real property on or before December 15, 2007 (was, September 1, 2007), and modifies the property descriptions. Requires the Governor to convey a perpetual conservation easement to the town for described property on or before March 15, 2008. Allows the Department of Health and Human Services (DHHS) to contract with the town to provide employees, equipment, and material and services for six months after incorporation and to lease property to the town any time after incorporation. Amends GS 122C-410 to give the town the right of first refusal for property within the town's extraterritorial jurisdiction and under the control of DHHS or the North Carolina Department of Agriculture. Provides that the town charter and proposed statutory changes become effective only if the charter is approved under the Voting Rights Act and provides for when the charter becomes effective. Requires the Department of Justice to be responsible for submitting any information required by GS 120-30.9F for pre-clearance under the Voting Rights Act. Provides that if the incorporation becomes effective, for taxes levied for the 2007-08 fiscal year, Granville County must remit the taxes collected on properties located within the corporate limits to the town instead of to the General Fund.

**H 986. BUTNER INCORPORATION.** Filed 3/22/07. House committee substitute makes the following changes to 2nd edition. Modifies the proposed charter to remove provisions creating staggered terms for members of the town council. Modifies Section 3(b)(24) of the bill to provide for the sales price if specified property is transferred or leased to a private party. Modifies the proposed amendment to GS 122C-403(3) by removing the requirement that the authorized board of adjustment consist of three or more persons. Corrects a reference to the Department of Agriculture and Consumer Services and makes technical changes to punctuation and capitalization.

**H 986. BUTNER INCORPORATION.** Filed 3/22/07. House amendment makes the following changes to 3rd edition. Modifies proposed Section 3(c) to specify that the subsection [allowing disposition by private negotiation and sale of real property described in Section 3(b)] does not apply to certain properties listed in Section 3(b).

**H 986. BUTNER INCORPORATION .** Filed 3/22/07. Senate amendment makes the following changes to 4th edition. Provides that if the Town of Butner's charter is not approved under

Section 5 of the Voting Rights Act of 1965 because of any provision in Article III (Governing Body) or IV (Elections) of the charter, the Butner Advisory Council may amend those articles as necessary to obtain approval.
