S 103. SPECIAL PLATE FOR PROSTATE CANCER AWARENESS. Filed 2/7/07. *TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO ISSUE A PROSTATE CANCER AWARENESS SPECIAL REGISTRATION PLATE.* Amends GS 20-79.4(b) as title indicates. Issuance of plate is contingent upon the receipt of at least 300 applications. Effective July 1, 2007.

S 103. VARIOUS SPECIAL LICENSE PLATES (NEW). Filed 2/7/07. Senate committee substitute makes the following changes to 1st edition. Amends GS 20-79.4 to also authorize the Division of Motor Vehicles to issue the following plates: (1) Breast Cancer Earlier Detection, (2) Hospice Care, and (3) Juvenile Diabetes Research Foundation. Eliminates the 300 application requirement for the issuance of the Gold Star Lapel Button plate. Amends GS 20-79.7(a) (fees) and GS 20-79.7(b) (distribution of fees) to include the additional authorized plates. Effective July 1, 2007, for fees transferred on or after July 1, 2007, amends GS 20-81.12(b14) to change the Omega Psi Phi plate funds recipient from the United Negro College Fund, Inc., to the Carolina Uplift Foundation, Inc., for youth activity and scholarship programs. Amends GS 20-81.12 to add the Hospice Care, Breast Cancer Earlier Detection, and Juvenile Diabetes Research Foundation plates, requiring that the plates receive 300 more applications before being developed and lists organizations that are to receive plate funds. Effective October 1, 2007, amends GS 20-79.7(b) to remove the additional fee for the Breast Cancer Awareness plate. Makes conforming changes to GS 20-79.7(b) and GS 20-79.4(b)(15), and a conforming repeal of GS 20-81.12(b53). Requires any funds remaining in the Collegiate and Cultural Attraction Plate Account as of October 1, 2007, derived from the sales of the Breast Cancer Awareness plate to be transferred to Friends for An Earlier Breast Cancer Test, Inc. Changes the effective date from July 1, 2007, to when the act becomes law. Makes conforming title change.

S 103. VARIOUS SPECIAL LICENSE PLATES. Filed 2/7/07. House committee substitute makes the following changes to 2nd edition. Amends GS 20-79.7(a) to direct the Division of Motor Vehicles to issue one registration plate free of charge to a recipient of a Gold Star Lapel Button and sets the additional fee for the plate at \$0. Conforms title.

June 26, 2007

S 103. VARIOUS SPECIAL LICENSE PLATES. Filed 2/7/07. House committee substitute makes the following changes to 3rd edition. Merges Section 8 and Section 4 and further amends GS 20-79.7 to increase the additional fee for the NC Coastal Federation from \$25 to \$30 and provide that the additional \$5 goes to the Collegiate and Cultural Attraction Plate Account. Amends various statutes in GS Chapter 20 to authorize issuance of the following special license plates and to provide for fees and for allocation of the proceeds of the fees: AIDS Awareness, ALS Research, Brain Injury Awareness, Home Care and Hospice, National Kidney Foundation, NC Tennis Foundation, and Triangle Native American Society. Amends GS 20-63(b) to provide that the following new plates do not have to bear the First in Flight design: AIDS Awareness, Home Care and Hospice, and NC Tennis Foundation. Effective January 1, 2008, amends GS 20-79.5 to authorize a special registration plate for the President of the Community Colleges System and to make technical corrections. Makes a conforming title change.

S 103. VARIOUS SPECIAL LICENSE PLATES. Filed 2/7/07. House committee substitute makes the following changes to 4th edition. Amends various statutes in GS Chapter 20 to remove authorization for the issuance of the Triangle Native American Society special license plate and related provisions for the plate fees and for the allocation of the fee proceeds.

July 31, 2007

S 103. VARIOUS SPECIAL LICENSE PLATES. Filed 2/7/07. Conference report recommends the following changes to 5th edition to reconcile matters in controversy. Modifies proposed amendments to GS 20-79.7 to provide that the Gold Star Lapel Button special plate is subject to the regular motor vehicle registration fee but not an additional fee. Conforms the title.

SL 2007-483 (S 103). VARIOUS SPECIAL LICENSE PLATES. AN ACT TO ELIMINATE THE REQUIREMENT OF THREE HUNDRED APPLICATIONS BEFORE THE DIVISION OF MOTOR VEHICLES IS AUTHORIZED TO PRODUCE THE GOLD STAR SPECIAL PLATE AND TO ELIMINATE THE ADDITIONAL FEE FOR THE GOLD STAR SPECIAL PLATE; TO CHANGE THE RECIPIENT OF FUNDS FROM THE OMEGA PSI PHI SPECIAL PLATE FROM THE UNITED NEGRO COLLEGE FUND, INC., TO THE CAROLINA UPLIFT FOUNDATION, INC., TO BE USED FOR YOUTH ACTIVITY AND SCHOLARSHIP PROGRAMS; TO ELIMINATE THE ADDITIONAL FEE AMOUNT FOR THE BREAST CANCER AWARENESS PLATE; TO INCREASE THE ADDITIONAL FEE FOR THE NC COASTAL FEDERATION PLATE; TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO ISSUE THE FOLLOWING NEW SPECIAL REGISTRATION PLATES: PROSTATE CANCER AWARENESS, JUVENILE DIABETES RESEARCH, BREAST CANCER EARLIER DETECTION, BRAIN INJURY AWARENESS, NC TENNIS FOUNDATION, ALS RESEARCH, NATIONAL KIDNEY FOUNDATION, AIDS AWARENESS, HOME CARE AND HOSPICE, AND HOSPICE CARE; TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO ASSIGN A SPECIAL REGISTRATION PLATE FOR THE PRESIDENT OF THE NORTH CAROLINA COMMUNITY COLLEGES SYSTEM; AND TO MAKE TECHNICAL CORRECTIONS IN THE STATUTE CONCERNING ASSIGNMENTS OF SPECIAL REGISTRATION PLATES TO STATE GOVERNMENT OFFICIALS.
