S 1256. 2007 STUDIES BILL. Filed 3/21/07. TO PROVIDE FOR STUDIES BY THE LEGISLATIVE RESEARCH COMMISSION. STATUTORY OVERSIGHT COMMITTEES AND COMMISSIONS, AND OTHER AGENCIES, COMMITTEES, AND COMMISSIONS.

Provides that the Legislative Research Commission may study specified topics; also provides for appointment of committee membership, reporting, and allocation of additional funds. Authorizes the statutory oversight committees and commissions to study a range of topics and report their findings, and provides for allocation of funds. Authorizes per diem, subsistence, and travel allowances for members of other commissions and committees, as well as staffing, the hiring of consultants, and allocation of funds. Intro. by Rand.

S 1256. 2007 STUDIES BILL. Filed 3/21/07. Senate committee substitute makes the following changes to 1st edition. Expands the topics for studies by the Legislative Research Commission. Lists bills or resolutions that proposed the issue or study and the name of the sponsor where applicable, for reference purposes only. Provides that unless specifically otherwise indicated, the listed bills and resolutions refer to measures introduced in the 2007 General Assembly. Requires that if a study is authorized in the act (the Studies Act of 2007) and in the Current Operations and Capital Improvements Appropriations Act of 2007 (2007 Appropriations Act), the study is to be implemented in accordance with the 2007 Appropriations Act as ratified. In addition to the Legislative Research Commission, adds numerous studies by various commissions, committees, departments, and agencies, as follows:

Amendment # 1 (1) deletes Early Childhood Programs from the Joint Legislative Education Oversight Studies and (2) authorizes the Director of the Budget, within funds available in any state agency, to use up to \$1.5 million for the Department of Administration study of the disparities in awarding state contracts to minority-owned and women-owned businesses.

Amendment # 2 adds wage disparity to the list of topics to be studied by the Legislative Research Commission, and expands the Joint Legislative Corrections, Crime Control, and Juvenile Justice Oversight Committee Studies to include the study of the potential for housing minimum-custody offenders in substance abuse treatment facilities; makes technical changes.

Deletes the study to authorize the Coastal Resources Commission to implement a pilot project to study the use of terminal groins for ocean inlet stabilization. Provides that if Senate Bill 448 is enacted, Section 17.2, providing for the DHHS to study and identify program and service needs for older adults in Brunswick and other counties, is repealed.

Makes additions, deletions, and corrections of sponsors identified on bills or resolutions that propose the issue or study. Makes technical, conforming, and stylistic changes. Includes sections reserved for future use.
