**S 1277. STATE DIESEL VEHICLES' WARRANTIES/B-20 FUEL.** Filed 3/21/07. *TO PROVIDE THAT ALL VEHICLES TRANSFERRED TO OR PURCHASED BY THE STATE THAT ARE CAPABLE OF OPERATING ON DIESEL FUEL SHALL HAVE A MANUFACTURER'S WARRANTY THAT COVERS THE USE OF B-20 FUEL.*

Amends GS 143-215.107C and GS 143-341(8), and enacts new GS 136-28.15 requiring that new vehicles purchased by the state and vehicles transferred to or purchased by the Department of Administration and Department of Transportation capable of running on diesel fuel must have a manufacturer's warranty that covers the use of B-20 fuel. Also includes definitions of B-20 and biodiesel fuel.

**S 1277. STATE DIESEL VEHICLES' WARRANTIES/B-20 FUEL.** Filed 3/21/07. Senate committee substitute makes the following changes to 1st edition. Limits to new motor vehicles the proposed amendment to GS 143-341(8)i.2 and proposed new GS 136-28.25, requiring that vehicles transferred or purchased by the state capable of operating on diesel fuel have a manufacturer's warranty covering the use of B-20 fuel.

**S 1277. STATE DIESEL VEHICLES' WARRANTIES/B-20 FUEL.** Filed 3/21/07. House committee substitute makes the following changes to 2nd edition. Deletes the proposed changes to GS 143-215.107C. Enacts new GS 20-351.11 requiring every new vehicle purchased by the state that is designed to operate on diesel fuel to be covered by an express manufacturer's warranty that allows the use of B-20 fuel. Provides that the statute does not apply if the intended use of the vehicle requires a type of vehicle for which such an express manufacturer's warranty is not available. Modifies proposed changes to GS 143-341(8)i. and proposed new GS 136-28.15 to specify that an express manufacturer's warranty is required for vehicles designed to operate (was, capable of operating) on diesel fuel and to provide that the requirement does not apply if the intended use of the vehicle requires a type of vehicle for which such an express manufacturer's warranty is not available. Changes the effective date from when the act becomes law, to January 1, 2008. Makes conforming title changes.

**SL 2007-420 (S 1277). STATE DIESEL VEHICLES' WARRANTIES/B-20 FUEL. AN ACT TO PROVIDE THAT ALL VEHICLES TRANSFERRED TO OR PURCHASED BY THE STATE THAT ARE DESIGNED TO OPERATE ON DIESEL FUEL SHALL BE COVERED BY AN EXPRESS MANUFACTURER'S WARRANTY THAT ALLOWS THE USE OF B-20 FUEL.**
