**S 1332. RAISE FEE CEIL'G/AMEND HEAR. AID DEALER LAWS.** Filed 3/21/07.

*AUTHORIZING THE NORTH CAROLINA STATE HEARING AID DEALERS AND FITTERS BOARD TO RAISE THE CEILING ON CERTAIN FEES AND AMENDING AND UPDATING CERTAIN OTHER PROVISIONS UNDER THE LAWS REGULATING HEARING AID DEALERS AND FITTERS.*

Increases maximum fees that may be charged for licensure examinations, travel expenses for the Board, and license applications and renewals. Adds a provision to GS 93D-13 to specify that documents containing information collected by the Board as a result of an investigation or inquiry conducted in connection with registration, licensure, or a disciplinary matter are not public record, except that notices, statements of charges, or decisions rendered in a disciplinary matter are public record. Provides that information identifying a consumer is not public unless the consumer consents to disclosure. Makes other clarifying and technical changes.

**S 1332. RAISE FEE CEIL'G/AMEND HEAR. AID DEALER LAWS.** Filed 3/21/07. Senate committee substitute makes the following changes to 1st edition. Amends GS 93D-11 to provide that in the case of a default in payment, in addition to by mail, the notice to the licensee may be sent by certified mail, or in a manner provided for in GS 1A-1, Rule 4(j)(1)d (by depositing with a designated delivery service a copy of the summons and complaint, addressed to the party to be served, delivering to the addressee, and obtaining a delivery receipt).

**S 1332. RAISE FEE CEIL'G/AMEND HEAR. AID DEALER LAWS.** Filed 3/21/07. House committee substitute makes the following changes to 2nd edition. Modifies proposed amendment to GS 93D-3(c)(14)f. to set the exam fee at \$300 (was, not to exceed \$300). Modifies proposed amendments to GS 93D-5(c) to remove persons holding doctoral degrees in Audiology from the exemption from the one year apprentice requirement and to exempt persons holding a license (was, masters degree) in Audiology who have met the specified requirements. Provides that the hearing aid fitting hours are to be done under the supervision of a licensed hearing aid dispenser (was, dealer). Makes technical corrections.
