S 1340. SALE OF BLOCKS OF TEN-DAY CRFLS. Filed 3/21/07. *TO PROVIDE FOR THE SALE OF BLOCKS OF TEN TEN-DAY COASTAL RECREATIONAL FISHING LICENSES.*

Creates new GS 113-174.5 to permit the resident owner of a vessel that is 26 feet or more in length and that is documented with the U.S. Coast Guard or registered with the Wildlife Resources Commission to purchase a block of 10 ten-day resident coastal recreational fisheries licenses (CRFLs) or a block of 10 ten-day nonresident CRFLs issued by the Division of Marine Fisheries (Division) in the Department of Environment and Natural Resources. Specifies the information that the vessel owner must supply to the Division. Sets fees for block purchases and the period of time for which CRFLs are valid. Effective July 1, 2007.

S 1340. SALE OF BLOCKS OF TEN-DAY CRFLS. Filed 3/21/07. Senate committee substitute makes the following changes to 1st edition. Reduces from 26 feet to 23 feet the minimum length of a vessel for which the owner may purchase a block of 10-day coastal recreational fishing licenses under proposed GS 113-174.5.

S 1340. SALE OF BLOCKS OF TEN-DAY CRFLS. Filed 3/21/07. House committee substitute makes the following changes to 3rd edition. Modifies proposed new GS 113-174.5 to provide for only one type of block of 10 Ten-Day Coastal Recreational Fishing Licenses (CRFLs), instead of one for residents and another for non-residents. Sets the fee for the block at \$150 and provides that a block of 10 Ten-Day CRFLs expires two years from purchase. Removes the requirement that a vessel owner be a resident in order to purchase a block of 10 Ten-Day CRFLs. Makes conforming and technical changes.
