S 1491. ADJUST PENALTY/ARSON & LARCENY. Filed 3/26/07. TO INCREASE THE CRIMINAL PENALTY FOR SECOND DEGREE ARSON AND TO AMEND THE PENALTY FOR CERTAIN OFFENSES OF LARCENY, EMBEZZLEMENT, AND OBTAINING PROPERTY BY FALSE PRETENSES BY AMENDING THE VALUE RANGES TO WHICH THE CRIMINAL PENALTIES APPLY.

Second degree arson: Amends GS 14-58 to increase from a Class G to a Class F felony the punishment for the offense of burning a dwelling that is unoccupied at the time of the burning.

Larceny of goods or property: Amends GS 14-72 to delineate penalties for larceny of goods or property and receiving or possessing stolen goods or property based on the value of the goods or property as follows:

Amends the following statutes as the chart below indicates to make changes in the criminal penalties for the indicated offenses based on the value of the property involved: GS 14-74, larceny by servants and other employees; GS 14-90, embezzlement of property received by virtue of office or employment; GS 14-91, embezzlement of state property by public officers and employees; GS 14-92, embezzlement of funds by public officers and trustees; GS 14-93, embezzlement by treasurers of charitable and religious organizations; GS 14-97, appropriation of partnership funds by partner to personal use; GS 14-98, embezzlement by surviving partner; GS 14-99, embezzlement of taxes by officers; and GS 14-100(a), obtaining anything of value by false pretense.
