S 1513. COUNTY FINANCING/HIGHWAY AND BRIDGE PROJECTS. Filed 3/27/07. TO ALLOW COUNTIES TO PARTICIPATE IN FINANCING IMPROVEMENT TO PUBLIC STREETS, HIGHWAYS, AND BRIDGES.

Amends GS 136-98 to authorize counties to participate in the cost of rights-of-way, construction, reconstruction, improvement, or maintenance of a road of the state highway system under agreement with the Department of Transportation. Amends GS 136-51 to specify that a county is authorized to acquire land by dedication and acceptance, purchase, or eminent domain and make improvements to portions of the state highway system using funds authorized for the purpose and in accordance with the specifications and requirements of the Department of Transportation. Amends GS 136-18(29a) to require that public or private entities planning schools request an evaluation from and meet recommendations made by the Department of Transportation for any highway improvements that are required for safe ingress and egress to the state highway system.

S 1513. COUNTY FINANCING/POWELL BILL/CITY ELECTION (NEW). Filed 3/27/07. Senate committee substitute makes the following changes to 2nd edition. Effective October 1, 2007, enacts new GS 136-41.4 to authorize a municipality that qualifies for funds under GS 136-41.1 (the Powell Bill) the option to accept all funds allocated to it under the statute for specified purposes or to have some or all of the allocation reprogrammed for a Transportation Improvement Project on the approved list. Sets the minimum amount to be reprogrammed. Conforms the title and effective date.

AN ACT TO ALLOW COUNTIES TO PARTICIPATE IN FINANCING IMPROVEMENTS TO PUBLIC STREETS, HIGHWAYS, AND BRIDGES; AND TO ALLOW MUNICIPALITIES THAT RECEIVE AN ALLOCATION OF FUNDS FROM THE HIGHWAY FUND AND THE HIGHWAY TRUST FUND WITH MONIES FOR REPAIR, MAINTENANCE, CONSTRUCTION, RECONSTRUCTION, WIDENING, OR IMPROVING STREETS OF THE MUNICIPALITY AN OPTION TO ELECT TO CONTINUE TO RECEIVE ALLOCATIONS OR HAVE THE ALLOCATION REPROGRAMMED TO FUND ANY PROJECT ON THE DEPARTMENT OF TRANSPORTATION'S TRANSPORTATION IMPROVEMENT LIST. Summarized in Daily Bulletin 3/27/07, 5/21/07, and 7/26/07. Enacted August 23, 2007. Section 5 is effective October 1, 2007. The remainder is effective August 23, 2007.
