Amends GS 160A-300.5(c) to also add the towns of Beulaville, Butner, Locust, and Oakboro to the list of towns and cities and towns that may regulate, by ordinance, the operation of golf carts on public streets or highways within the city or town limits, or on any property owned or leased by the city or town. Essentially combines the following bills: (1) SB 1598 (Hobgood), (2) SB 1622 (Locust, Oakboro), (3) SB 1722 (Beulaville), and (4) SB 1645 (Butner). Makes conforming changes to the title.

### June 10, 2008

**S 1598. REGULATION OF GOLF CARTS VARIOUS LOCALITIES.** Filed 5/14/08. Senate committee substitute makes the following changes to 2nd edition. Makes a clarifying correction to list Locust as one of the cities to which GS 160A-300.5(c) applies rather than in the list of towns. Makes a technical and conforming change to the title.

**S 1598. REGULATION OF GOLF CARTS VARIOUS LOCALITIES.** Filed 5/14/08. House committee substitute makes the following changes to 3rd edition. Amends GS 160A-300.5 to add New Hanover County, the City of Wilmington, the towns of Erwin, Mayodan, Mount Olive, and Pineville, and the Village of Pinehurst to *cities* (was, town) authorized to regulate golf carts under certain conditions. Defines *city* to include a city, a town, a village, or a county for the purposes of this section. Defines *county* to mean any unincorporated areas within that county boundary.

Adds that Mayodan must not enact any ordinances regulating golf carts until a public hearing is held and the governing body votes to approve the issue.

Makes conforming changes to the title.
