S 184. PROTECT JUDGE'S SAFETY. Filed 2/14/07. *TO ALLOW JUSTICES AND JUDGES TO LIST A BUSINESS ADDRESS ON A STATEMENT OF ECONOMIC INTEREST AND TO ALLOW THE ADDRESS OF A SPOUSE AND THE NAMES AND ADDRESSES OF MINOR CHILDREN TO REMAIN CONFIDENTIAL.* Amends GS 138A-24(a)(1) (which involves a statement of economic interest that must be filed with the State Ethics Commission) for the purpose indicated in the title.

S 184. PROTECT JUDGES SAFETY. Filed 2/14/07. Senate committee substitute makes the following changes to 1st edition. Allows a justice or judge to use initials of a child living in the household (was, required the use of initials). Makes the child's name, which is filed with the commission, privileged and confidential. Removes provisions for address of the spouse. Amends GS 138A-22(d) to add a reference to GS 163-323 (regarding Appellate, Superior, and District Court judges notice of candidacy) requiring candidates to file the statement of economic interest at the same time and manner as the notice of candidacy within 10 days of the filing deadline. Changes effective date to January 1, 2007. Makes conforming title change.

S 184. PROTECT JUDGES SAFETY. Filed 2/14/07. Senate amendment makes the following changes to 2nd edition. Includes district attorneys (was, only justices and judges) in those who may list a business address and use a child's initials on forms. Makes conforming title change.

April 17, 2007

S 184. PROTECT JUDICIAL OFFICER SAFETY (NEW). Filed 2/14/07. House committee substitute makes the following changes to 3rd edition. Changes title to *AN ACT TO ALLOW JUDICIAL OFFICERS TO LIST A BUSINESS ADDRESS ON A STATEMENT OF ECONOMIC INTEREST AND TO KEEP THEIR HOME ADDRESSES AND THE NAMES OF THEIR UNEMANCIPATED MINOR CHILDREN CONFIDENTIAL.* Amends GS 138A-24(a) to insert the phrase *judicial officer* and delete the phrase *justice, judge, or district attorney*. GS 138A-3 defines judicial officer to include justice, judge, district attorney, or clerk of court, so this change expands the bill to cover clerks of court.

AN ACT TO ALLOW JUDICIAL OFFICERS TO LIST A BUSINESS ADDRESS ON A STATEMENT OF ECONOMIC INTEREST AND TO KEEP THEIR HOME ADDRESSES AND THE NAMES OF THEIR UNEMANCIPATED MINOR CHILDREN CONFIDENTIAL.
