Filed 2/20/07. *CONCERNING INVESTMENTS OF THE CITY OF CHARLOTTE.* Adds new Article VII (Investment Authority) to Charlotte's City Charter, SL 2000-26, allowing the city to invest any employee benefit funds, risk reserve funds, cemetery perpetual care funds, and capital reserves in securities or other investments authorized for the State Treasurer.

S 221. CHARLOTTE FINANCE INVESTMENT AUTHORITY. Filed 2/20/07. Senate committee substitute makes the following changes to 1st edition. Allows the City of Charlotte to invest municipal funds in the types of securities or other investments authorized by law for the State Treasurer in designated subdivisions of GS 147-69.2(b) [was, more broadly under GS 147-69.2].

S 221. CHARLOTTE MECKLENBURG INVESTMENT AUTHORITY (NEW). Filed 2/20/07. House committee substitute makes the following changes to 2nd edition. Modifies the proposed new Article VII to specify that employee benefit funds that are held in trust may be invested by the city. Authorizes Mecklenburg County or any entity contracting with the county to invest any employee benefit funds held in trust, risk reserve funds, and capital reserves in securities or other investments authorized for the State Treasurer in designated subdivisions of GS 147-69.2(b). Makes a conforming title change.

S 221. CERTAIN LOCAL GOVERNMENTS' INVESTMENTS (NEW). Filed 2/20/07. House committee substitute makes the following changes to 3rd edition. Changes title to *AN ACT CONCERNING INVESTMENTS OF THE CITIES OF CHARLOTTE, GREENSBORO, AND RALEIGH, AND THE COUNTIES OF GUILFORD, MECKLENBURG, AND WAKE.* Adds the cities of Greensboro and Raleigh and Guilford and Wake counties to the provision permitting any entity contracting with the unit to invest any employee benefit funds held in trust, risk reserve funds, and capital reserves in securities or other investments authorized for the State Treasurer in designated subdivisions of GS 147-69.2(b).
