**S 30. DV VICTIMS/ADD PROTECTIONS.** Filed 1/29/07. *TO AMEND LAWS TO PROVIDE GREATER PROTECTION FOR DOMESTIC VIOLENCE VICTIMS AS RECOMMENDED BY THE JOINT LEGISLATIVE COMMITTEE ON DOMESTIC VIOLENCE.* Amends GS 101-2 to allow an applicant seeking a name change, who provides evidence that the applicant is a victim of domestic violence, sexual offense, or stalking, to be exempt from the publication requirement. Amends GS 15A-830(a)(7) to include in the definition of *victim* for purposes of the Crime Victims' Rights Act, a person against whom there is probable cause to believe that there has been a violation of a valid protective order under GS 50B-4.1. Expands GS 50B-3(c1) to require that the informational sheet provided to the applicant upon the filing of a 50B protective order must list specific service and resource agencies. Effective October 1, 2007.

**S 30. DV VICTIMS/ADD PROTECTIONS.** Filed 1/29/07. Senate committee substitute makes the following changes to 1st edition. Adds GS 101-2(b) to provide that the application and court record regarding name change proceedings are not required to be published where the applicant has provided evidence that he or she is a victim of domestic violence, sexual offense, or stalking, as provided in GS 101-2(a) or is a participant in the address confidentiality program under GS Chapter 15C. No longer allows documentation from a religious, medical, or other professional from which the applicant has sought assistance as evidence of domestic violence, sexual offense, or stalking. Also provides that such records are to be maintained separately from other records and may be examined only by court order or with the applicant's written consent.
