**S 320. STATEWIDE CERTIFICATION OF HUBS.** Filed 2/22/07. AUTHORIZING THE SECRETARY OF ADMINISTRATION TO DEVELOP AND ADMINISTER A STATEWIDE UNIFORM CERTIFICATION PROGRAM FOR HISTORICALLY UNDERUTILIZED BUSINESSES DOING BUSINESS WITH STATE DEPARTMENTS, AGENCIES, AND INSTITUTIONS, AND POLITICAL SUBDIVISIONS OF THE STATE. Enacts new GS 143-48.4 and amends GS 143-128.4 to give the Secretary of Administration authority to: (1) develop and administer a program for the certification of historically underutilized businesses doing business with state departments, agencies, institutions, and political subdivisions of the state; (2) to create a database of the businesses certified; and (3) adopt rules and procedures for the certification. Repeals similar provisions of current law in GS 143-48(d1) and GS 143-128.3(e1). Intro. by Dorsett. GS 143

## April 30, 2007

**S 320. STATEWIDE CERTIFICATION OF HUBS.** Filed 2/22/07. Senate committee substitute makes the following changes to 1st edition. Modifies proposed GS 143-48.4 and GS 143-128.4(c) to provide that it is also the duty (in addition to a power) of the Secretary of Administration to perform listed tasks. Changes the effective date from when the act becomes law to July 1, 2007.

## July 26, 2007

**S 320. STATEWIDE CERTIFICATION OF HUBS.** Filed 2/22/07. House committee substitute makes the following changes to 2nd edition. Makes clarifying and technical changes. Effective July 1, 2009, modifies proposed GS 143-48.4 to direct that state entities use only historically underutilized businesses identified as minority businesses in the database created per the provisions of GS 143-48.4. Further amends GS 143-128.4 to add a definition for *minority business*. Directs the Secretary of Administration to develop the statewide uniform program and criteria for statewide uniform certification of historically underutilized businesses as prescribed in the act no later than March 31, 2008. Unless otherwise indicated, the act is effective October 1, 2007 (was, July 1, 2007).

SL 2007-392 (S 320). STATEWIDE CERTIFICATION OF HUBS. AN ACT AUTHORIZING THE SECRETARY OF ADMINISTRATION TO DEVELOP AND ADMINISTER A STATEWIDE UNIFORM CERTIFICATION PROGRAM FOR HISTORICALLY UNDERUTILIZED BUSINESSES DOING BUSINESS WITH STATE DEPARTMENTS, AGENCIES, AND INSTITUTIONS, AND POLITICAL SUBDIVISIONS OF THE STATE. Summarized in Daily Bulletin 3/22/07, 4/30/07, and 7/26/07. Enacted August 19, 2007. GS 143-48.4(c)(1) and (2), as enacted by Section 2, and GS 143-128.4(e), as enacted by Section 4, are effective July 1, 2009. The remainder is effective October 1, 2007.
