S 384. GRANVILLE COUNTY OCCUPANCY TAX MODIFICATIONS. Filed 2/27/07. *TO AUTHORIZE GRANVILLE COUNTY TO LEVY AN ADDITIONAL ROOM OCCUPANCY AND TOURISM DEVELOPMENT TAX.*

Amends SL 1993-454, as amended, to authorize the Granville County Board of Commissioners to levy an additional room occupancy tax of up to 1%. Provides that the tax must be levied, administered, collected, and repealed in the same way as the existing tax. Effective October 1, 2007, requires the Granville County Tourism Development Authority (Authority) to use at least two-thirds of the total occupancy tax proceeds for capital expenditures for tourism-related projects and the remainder to promote travel and tourism. Beginning October 1, 2014, the Authority must use at least two-thirds of the proceeds to promote travel and tourism in Granville County and the remainder for tourism-related expenditures.

S 384. GRANVILLE COUNTY OCCUPANCY TAX MODIFICATIONS. Filed 2/27/07. Senate committee substitute makes the following changes to 1st edition. Modifies proposed new SL 1993-454, Section 1 (a1) to authorize the levy of an additional occupancy tax of 1% (was, of up to 1%). Amends the effective date to provide that the additional occupancy tax may not become effective before October 1, 2007 (was, October 1, 2004). Amends the title.

S 384. GRANVILLE COUNTY OCCUPANCY TAX MODIFICATIONS. Filed 2/27/07. House committee substitute makes the following changes to 2nd edition. Rewrites proposed use of the tax proceeds so that (1) two-thirds of the new tax must be used to promote travel and tourism and the remainder must be used for tourism-related expenditures and (2) from October 1, 2007, through October 1, 2019, two-thirds of the first 3% must be used for tourism-related expenditures and the remainder must be used to promote travel and tourism. After October 1, 2019, the first 3% must be used in the same proportion as the new tax. Reorganizes the definitions. Makes the authority to levy the new tax effective October 1, 2007.
