S 448. STUDY/BRUNSWICK COUNTY. Filed 3/1/07. *DIRECTING THE DEPARTMENT OF HEALTH AND HUMAN SERVICES TO CONDUCT A STUDY TO IDENTIFY THE NEEDS OF THE AGING POPULATION IN BRUNSWICK AND OTHER COUNTIES.*

Directs the Department of Health and Human Services, Division of Aging and Adult Services (Division), to study the aging population in Brunswick County and other counties experiencing significant increases in the aging population. The Division must report its findings to the 2008 Regular Session and to the board of county commissioners of each county studied no later than May 1, 2008. Effective July 1, 2007.

S 448. STUDY/BRUNSWICK COUNTY. Filed 3/1/07. Senate committee substitute makes the following changes to 1st edition. Broadens the study's scope, directing the Department of Health and Human Services, Division of Aging and Adult Services (DHHS) to study the population profile of Brunswick and the other counties (was, study aging population). Identifies the purpose of the study as determines the anticipated impact of the increase in the number of persons 65 years or older on programs and services that address the needs of the older adult population. Changes the date for DHHS to report its findings and recommendations from May 1, 2008, to April 1, 2008, and adds the North Carolina Study Commission on Aging to the list of agencies to receive the study report. Changes the title to *A BILL TO BE ENTITLED AN ACT DIRECTING THE DEPARTMENT OF HEALTH AND HUMAN SERVICES TO STUDY AND IDENTIFY PROGRAM AND SERVICE NEEDS FOR OLDER ADULTS IN BRUNSWICK AND OTHER COUNTIES.*

S 448. STUDY OLDER ADULT PROGRAMS/VARIOUS COUNTIES (NEW). Filed 3/1/07. House committee substitute makes the following changes to 2nd edition. Changes the title to *AN ACT DIRECTING THE DEPARTMENT OF HEALTH AND HUMAN SERVICES, DIVISION OF AGING AND ADULT SERVICES, TO STUDY PROGRAM AND SERVICE LEVELS AND NEEDS FOR OLDER ADULTS IN BRUNSWICK, BUNCOMBE, GASTON, HENDERSON, MOORE, AND NEW HANOVER COUNTIES.* Rewrites the bill to provide as title indicates. Requires the Division of Aging and Adult Services to (1) work with other specified state and county agencies to conduct the study; (2) make an interim report to the NC Study Commission on Aging (commission) by November 1, 2007; (3) make a final report to the commission, the General Assembly, and the studied counties by April 1, 2008; and (4) recommend to the commission by January 1, 2008, a study of all counties.
