S 652. ROCKINGHAM OVERGROWN VEGETATION ORDINANCE. Filed 3/7/07. Senate committee substitute makes the following changes to 1st edition. Modifies proposed amendment to GS 160A-200(b) by adding the cities of Eden and Reidsville. Conforms the title.

June 25, 2007

S 652. LOCAL OVERGROWN VEGETATION ORD./EDEN CHARTER (NEW). Filed 3/7/07. House committee substitute makes the following changes to 2nd edition. Amends a provision of the Eden City Charter allowing a change in the compensation of the mayor and city council to take effect during the same term it is adopted. Conforms the title.

June 27, 2007

S 652. LOCAL OVERGROWN VEGETATION ORD./EDEN CHARTER. Filed 3/7/07. House committee substitute makes the following changes to 3rd edition. Repeals the provision of the Eden City Charter that was amended in the 3rd edition, with the result being that general law will govern setting the compensation of the mayor and city council. Conforms the title.

July 18, 2007

S 652. LOCAL OVERGROWN VEGETATION ORD./EDEN CHARTER. Filed 3/7/07. Conference report recommends the following changes to 4th edition to reconcile matters in controversy. Deletes the provision that would have repealed a section of the City of Eden's charter governing compensation of the mayor and city council and instead authorizes the city to repeal the section, but only by ordinance amending its charter, which must be filed with the Secretary of State and the Legislative Library. Conforms the title.
