S 684. SPAY/NEUTER FUNDING. Filed 3/12/07. *TO PROVIDE FOR FUNDING FOR THE STATEWIDE SPAY AND NEUTER PROGRAM FROM THE SALE OF RABIES VACCINATION TAGS.*

S 684. SPAY/NEUTER FUNDING. Filed 3/12/07. *TO PROVIDE FOR FUNDING FOR THE STATEWIDE SPAY AND NEUTER PROGRAM FROM THE SALE OF RABIES VACCINATION TAGS.*

Amends GS 130A-190 as title indicates and requires the Secretary of Health and Human Services to establish a tag fee of not less than fifty cents to replace the existing voluntary tag and fee. Fee proceeds to be credited to the spay/neuter account. Exempts from the fee tags provided to a person owning five or more dogs and registered with the Department of Agriculture and Consumer Services as a dog breeder. Makes conforming change to GS 19A-62(a). Effective January 1, 2008.

S 684. SPAY/NEUTER FUNDING. Filed 3/12/07. Senate committee substitute makes the following changes to 1st edition. Deletes proposed GS 130A-190(b1) and instead modifies GS 130A-190 to increase the cost of a rabies tag by \$0.20, which is to be credited to the Spay/Neuter Account to fund statewide programs. Prohibits this fee from being charged for tags provided to individuals who own and vaccinate ten or more dogs per year. Makes a conforming change to GS 19A-62 and provides that if the revenue generated by the portion of the fee for prevention and education programs is less than \$47,500 for the fiscal year, then the difference may be used from the Spay/Neuter Account. Provides that a county or city is ineligible to receive funds remaining in the account for reimbursement for reduced cost spay/neuter surgeries unless the city or county requires the owner to show proof of rabies vaccination at the time of the procedure, or requires vaccination at the time of the procedure.

S 684. SPAY/NEUTER FUNDING. Filed 3/12/07. Senate amendment makes the following changes to 2nd edition. Directs that the new twenty cents of the rabies vaccination tag fee not be assessed on tags purchased by persons who operate establishments primarily for the purpose of boarding or training hunting dogs.

S 684. SPAY/NEUTER FUNDING. Filed 3/12/07. House committee substitute makes the following changes to 3rd edition. Directs the Department of Health and Human Service to report annually to the Joint Legislative Commission on Governmental Operations and the Fiscal Research Division on the Spay/Neuter Account. Conforms the title.
