**S 692. BOXING ADVISORY COMMISSION.** Filed 3/12/07. *TO ESTABLISH THE BOXING ADVISORY COMMISSION.*

Enacts new GS 143-652.2 creating the Boxing Advisory Commission, to advise the Alcohol Law Enforcement Division (ALE) of the Department of Crime Control and Public Safety in its regulation of boxing. Provides for six voting members, with one each appointed by the Governor, Senate President Pro Tem., and Speaker of the House of Representatives, two appointed by the Secretary of Crime Control and Public Safety (Secretary), and one appointed by the Tribal Council of the Eastern Band of the Cherokee. (The latter appointment is conditioned upon an agreement being in place between the Tribal Council and the commission authorizing the commission to regulate boxing matches within the Cherokee Reservation.) Provides in addition for two nonvoting members, one each appointed by the Senate President Pro Tem. and the Speaker from two nominees of the N.C. Medical Society. Provides for three-year terms, with initial staggering. Provides that the Secretary is to designate a chair and gives the Secretary the right to remove any member for cause.

Directs the new commission to review existing boxing rules and recommend changes to the ALE and requires that any proposed changes to rules be submitted to the commission for comment. Provides that medical members of the commission are to advise the commission and ALE on matters concerning health and physical condition of boxers and health issues relating to the conduct of exhibitions and matches. Effective July 1, 2007.

Modifies proposed new GS 143-652.2 to remove the requirement that members of the Boxing Advisory Commission meet the membership requirements of the Professional Boxing Safety Act of 1996 (act) and adds a provision stating that members of the commission are subject to the conflict of interest requirement contained in the act. Changes the effective date from July 1, 2007, to August 1, 2007.
