S 770. LICENSURE CHANGES/HOSP. ADULT CR. HMS., MH.AB. Filed 3/14/07. TO AUTHORIZE THE SECRETARY OF HEALTH AND HUMAN SERVICES TO SUSPEND ADMISSIONS OR SERVICES IN HOSPITALS AS PART OF TAKING ADVERSE ACTION AGAINST A HOSPITAL'S LICENSE; TO ALLOW FOR THE WAIVER OF HOSPITAL LICENSURE RULES DURING AN EMERGENCY; TO ALLOW CRIMINAL BACKGROUND CHECKS OF EMPLOYEES OF LICENSED MENTAL HEALTH FACILITIES BY PRIVATE ENTITIES; TO MAKE TECHNICAL CORRECTIONS IN THE HEALTH CARE PERSONNEL REGISTRY STATUTES; TO REQUIRE FINES TO BE PAID PRIOR TO TRANSFER OF OWNERSHIP OF ADULT CARE HOMES; AND TO CHANGE TIME FRAMES OF INVESTIGATIONS OF ADULT CARE HOMES.

Amends GS 131E-78 to authorize the Secretary of the Department of Health and Human Services (DHHS) to suspend the admission of new patients or specific services when a hospital fails to comply with licensure provisions and establishes factors to be considered in deciding whether to suspend admissions or services. Requires DHHS to work with the hospital to correct the conditions that led to the suspension. Allows a facility to contest an adverse action by filing a petition within 20 days after receiving notice of the action. Enacts new GS 131E-84 allowing the Division of Facility Services to temporarily waive the rules pertaining to a hospital in the event of a disaster or emergency to the extent necessary for the hospital to provide temporary shelter and services. Amends GS 112C-80 to allow a request for a criminal history check to be submitted to a private entity (was, only to the Department of Justice). Amends GS 131D-2 to prohibit a new license from being issued for a change in ownership of an adult care home if there are outstanding fees or penalties. Amends GS 131D-26 to remove the requirement that investigations of complaints of violations at adult care homes be completed within 30 days. Makes technical changes.
