UNC SMOKE-FREE (=H 760).** Filed 3/15/07. *TO ALLOW REGULATION OF SMOKING ON THE CAMPUSES OF THE UNC HEALTH CARE SYSTEM, THE FACILITIES OF THE EAST CAROLINA SCHOOL OF MEDICINE AND PHYSICIANS PRACTICE PLAN, AND THE BUILDINGS AND GROUNDS OF THE CONSTITUENT INSTITUTIONS OF THE UNIVERSITY OF NORTH CAROLINA.*

**S 862. UNC SMOKE-FREE.** Filed 3/15/07. Senate committee substitute makes the following changes to 1st edition. Reorganizes GS 143-596 and modifies the definition of *grounds* by specifying that the area must be controlled by the state. Modifies the proposed amendment to GS 143-597(a)(6) by defining the term *facilities* as "buildings owned, leased as lessor, or the area of the building leased as lessee that is occupied by the University of North Carolina."

**S 862. UNC SMOKE-FREE.** Filed 3/15/07. House committee substitute makes the following changes to 2nd edition. Amends GS 143-596 to add definitions of *constituent institution*, *medical faculty practice plan*, *the University of North Carolina (UNC)*, and *the University of North Carolina Health Care System*. Amends the definition of *grounds* to clarify that it is the area located and controlled by state government that is within 100 linear feet of any of: (1) a state-owned building that is allocated to and occupied by state government, (2) a state-owned building leased to a third party, and (3) a building owned by a third party and leased to state government. Amends GS 143-597(a)(6) to provide that except as provided in GS 143-599(11) (certain UNC health care facilities), facilities of UNC and the facility grounds may be designated as nonsmoking. Excludes the North Carolina School of Science and Mathematics from the requirement that each constituent institution make a reasonable effort to provide residential smoking rooms in proportion to student demand. Makes a conforming change by deleting a reference to the School of Science and Mathematics. Clarifies that the definition of *facilities* includes: (1) state-owned buildings allocated to and occupied by UNC, (2) state-owned buildings allocated to UNC and leased to a third party, and (3) the area of the building owned by a third party and occupied by UNC as lessee. Changes the effective date from when the act becomes law to July 1, 2007. Makes technical and stylistic changes.
