Modifies GS 159C-3(15a), which lists the types of projects eligible to be financed under the Private Capital Facilities Finance Act, to simplify the proposed description of facilities for the provision of material salvage and recycling services whose proceeds are used to provide for low, moderate, or affordable housing. Adds an additional eligible project: facilities for the provision of research conducted by a nonprofit corporation organized by two or more accredited universities whose main campuses are in North Carolina. Makes conforming changes to title.

S 966. BONDS—EXPAND SPECIAL PURPOSE PROJECTS (NEW). Filed 3/9/07. House committee substitute makes the following changes to 2nd edition. Amends GS 159C-3(15a) to include in the definition of a special purpose project any structure, equipment, or other facility with the following purposes: (1) research facilities owned or operated by a nonprofit corporation incorporated by two or more accredited universities whose main campuses are located in North Carolina, or by the Chancellor, President or, similar university official (was, facilities for the provision of research by a nonprofit organized by two or more accredited universities whose main campuses are located in North Carolina) and (2) facilities housing the international headquarters of a nonprofit society that is a member of the Scholarly Societies Project. Amends GS 159D-37(6a) to provide that the term project for purposes of the Private Capital Facilities Financing Act includes all appurtenances and incidental facilities related to the operation of the project or essential for the conduct of the facility. Also removes references to structures. Makes a conforming title change.
