H 1073. FIRE AND RESCUE PENSION WITHDRAWAL CHANGE. Filed 4/2/09. *TO PROVIDE THAT MEMBERS OF THE FIRE AND RESCUE PENSION FUND WHO WITHDRAW FROM MEMBERSHIP ARE ENTITLED TO THE RETURN OF ALL FUNDS.*

H 1073. FIRE AND RESCUE PENSION WITHDRAWAL CHANGE. Filed 4/2/09. House committee substitute makes the following changes to 1st edition. Changes title to *AN ACT TO PROVIDE THAT MEMBERS OF THE FIREMEN'S AND RESCUE SQUAD WORKERS' PENSION FUND WHO WITHDRAW FROM MEMBERSHIP WITH FIVE YEARS OR MORE OF CONTRIBUTING SERVICE ARE ENTITLED TO THE RETURN OF ALL FUNDS AND TO REPEAL THE AUTHORIZATION FOR AN ADMINISTRATIVE FEE TO BE APPLIED TO THOSE WITHDRAWALS.* Amends proposed changes to GS 58-86-60(4) as title indicates.

H 1073. FIRE AND RESCUE PENSION WITHDRAWAL CHANGE. Filed 4/2/09. Senate committee substitute makes the following changes to 2nd edition. Provides in proposed amended GS 58-86-60(4) that only members *with five or more years of contributing service* (was, any member) and who withdraw from the Firemen's and Rescue Squad Workers' Pension Fund (Fund) may be paid, upon proper application, all moneys without accumulated earnings on the payments after the time they were made less an administrative fee equal to the lesser of the amount the individual contributed to the fund or \$25. Adds that any member who has less than five years of contributing service, in addition to any person, firm, corporation, or other entity that made contributions on behalf of a member who has less than five years of contributing service, who withdraws from the Fund is entitled to a refund equal to the amount of contributions made by that entity after the Board of Trustees has been notified of the member's desire to be refunded its contributions upon withdrawal.

Changes the title to *AN ACT TO PROVIDE THAT MEMBERS OF THE FIREMEN'S AND RESCUE SQUAD WORKERS' PENSION FUND WHO WITHDRAW FROM THE MEMBERSHIP WITH FIVE YEARS OR MORE OF CONTRIBUTING SERVICE ARE ENTITLED TO THE RETURN OF ALL FUNDS.*
