H 1078. REPORT SCHOOL VIOLENCE TO LEA OFFICE. Filed 4/2/09. *TO ENSURE THAT ACTS OF VIOLENCE IN SCHOOLS ARE REPORTED TO THE LOCAL SUPERINTENDENT OR THE SUPERINTENDENT'S DESIGNEE.*

Amends GS 115C-288(g) to require that the principal, within two business days of making a report to law enforcement (concerning an act on school property involving assault resulting in serious physical injury, sexual assault, sexual offense, rape, kidnapping, indecent liberties with a minor, assault involving the use of a weapon, possession of a firearm, weapon, or controlled substance in violation of the law), notify the superintendent or the superintendent's designee in writing or by electronic mail. Also requires the superintendent to provide the information to the local board. (Current law states the General Assembly's intent that the principal notify the superintendent and that the superintendent notify the local board of any report made to law enforcement.)

H 1078. REPT SCH VIOL TO SUPER./REQ. NOTIF. POLICY (NEW). Filed 4/2/09. Senate committee substitute makes the following changes to 1st edition. Provides in proposed amended GS 115C-288(g) that the principal or the principal's designee must notify the superintendent or the superintendent's designee in writing or by electronic mail, as practicable, by the end of the workday on the day of making the required report to law enforcement regarding certain acts under the statute but no later than the following workday (was, within two business days of making the report). Makes other clarifying and conforming changes.

Amends GS 115C-47 to add that local boards of education must adopt a policy on the notification to parents or legal guardians of any students alleged to be victims of any act that is required to be reported to law enforcement and the superintendent under GS 115C-288(g). Specifies that this provision applies beginning with the 2010-11 school year.

Changes the title to *AN ACT TO ENSURE THAT ACTS OF VIOLENCE IN SCHOOLS ARE REPORTED TO THE LOCAL SUPERINTENDENT OR THE SUPERINTENDENT'S DESIGNEE AND TO REQUIRE LOCAL BOARDS OF EDUCATION TO ADOPT A POLICY ON NOTIFICATION TO THE PARENTS OR LEGAL GUARDIANS OF STUDENTS ALLEGED TO BE VICTIMS OF ANY ACT REQUIRED TO BE REPORTED TO LAW ENFORCEMENT AND THE SUPERINTENDENT.*
