**H 1110. CLARIFY/ALIEN. OF AFFECTION/CRIM. CONVERSAT'N.** Filed 4/6/09. *TO CLARIFY PROCEDURES IN CIVIL ACTIONS FOR ALIENATION OF AFFECTION AND CRIMINAL CONVERSATION.*

Enacts new GS 52-13 to provide that no act of the defendant gives rise to a cause of action for alienation of affection or criminal conversation after the date of separation. Prohibits an action for alienation of affection or criminal conversation from being commenced more than one year from the last act of the defendant giving rise to the cause of action. Requires the date of separation to be interpreted according to GS Chapter 50 and allows for the commencement of a cause of action against a natural person only. Applies to actions commenced on or after the date that the act becomes law.

**H 1110. CLARIFY/ALIEN. OF AFFECTION/CRIM. CONVERSAT'N.** Filed 4/6/09. House committee substitute makes the following changes to 1st edition. Amends proposed GS 52-13 to provide that no act of the defendant that occurs more than 60 days after the date of separation (was, act of the defendant after the date of separation) gives rise to a cause of action for alienation of affection or criminal conversation. Provides that an action for alienation of affection or criminal conversation must not be commenced more than three years (was, one year) from the last act of the defendant giving rise to the cause of action.

**H 1110. CLARIFY/ALIEN. OF AFFECTION/CRIM. CONVERSAT'N.** Filed 4/6/09. House committee substitute makes the following changes to 2nd edition. Amends proposed new GS 52-13 by providing that no act shall give rise to an action for alienation of affection or criminal conversation if it occurs after the date of separation (was, more than 60 days after date of separation).

**H 1110. CLARIFY/ALIEN. OF AFFECTION/CRIM. CONVERSAT'N.** Filed 4/6/09. House amendment makes the following changes to 3rd edition. Specifies that the act applies to actions occurring on or after the effective date.

**H 1110. CLARIFY/ALIEN. OF AFFECTION/CRIM. CONVERSAT'N.** Filed 4/6/09. Senate committee substitute makes the following changes to 4th edition. Amends proposed GS 52-13 to prohibit an act of the defendant occurring after the plaintiff and the plaintiff's spouse physically separate with the intent of either the plaintiff or the plaintiff's spouse that the physical separation remain permanent (was, after the date of separation of the claimant and the claimant's spouse) from giving rise to an action for alienation of affection or criminal conversation. Makes organizational changes and a conforming deletion. Changes the effective date to October 1, 2009 (was, when the act becomes law).
