Changes the title to *AN ACT TO CLARIFY DOMESTIC VIOLENCE LAWS REGARDING WHEN A LAW ENFORCEMENT OFFICER SHALL ARREST A PERSON WHO HAS KNOWINGLY VIOLATED A VALID PROTECTIVE ORDER DESPITE THE 2006 HOLDING BY THE NORTH CAROLINA COURT OF APPEALS IN COCKERHAM-ELLERBEE V. THE TOWN OF JONESVILLE. Adds whereas clauses regarding the North Carolina Court of Appeals holding in Cockerham-Ellerbee v. The Town of Jonesville (a 2006 case) that GS 50B-4.1(b) was a discretionary provision rather than a mandatory one, and noting that the General Assembly intended GS 50B-4.1(b) to create a mandatory provision. Deletes section 1 of the 1st edition, and instead of amending GS 50B-4.1(b), states in the new section 1 that GS 50B-40.1(b) creates a mandatory provision requiring a law enforcement officer to arrest and take a person into custody without a warrant or other process if the requirements set forth in GS 50B-4.1(b) are met.*

Amends GS 50B-4.1(b) to clarify that a law enforcement officer must arrest and take a person into custody with or without (was, without) a warrant or other process if the officer has probable cause to believe that the person knowingly has violated a valid protective order excluding the person from the residence occupied by a victim of domestic violence or directing the person to refrain from threatening, abusing, or following the other party, harassing the other party, or otherwise interfering with the other party.
