**H 1682. BAN CORP. PUNISH. FOR CHILDREN W/DISABILIT.** Filed 5/12/10. *TO PROHIBIT THE USE OF CORPORAL PUNISHMENT FOR STUDENTS WITH DISABILITIES AS RECOMMENDED BY THE JOINT LEGISLATIVE EDUCATION OVERSIGHT COMMITTEE.*

Amends GS 115C-107.7 as title indicates. Makes conforming and other technical changes to GS 115C-391. Applies beginning in the 2010-11 school year.

**H 1682. CORP. PUNISH. AND CHILDREN W/DISABILIT (NEW).** Filed 5/12/10. House committee substitute makes the following changes to 1st edition. Removes proposed provision that prohibited administering corporal punishment to students with disabilities; instead, amends GS 115C-107.7 to require that corporal punishment administered to students with disabilities be consistent with the requirements of GS 115C-391(a)(5) (permits the use of corporal punishment to maintain order on school property, in the classroom, or at school-related activities on or off school property). Amends GS 115C-391 to prohibit the administration of corporal punishment on a student with a disability as defined in GS 115C-106.3(1) or covered under Section 504 of the federal Rehabilitation Act of 1973 (was, as defined in GS 115C-106.3(1)), *if* the parent or guardian has stated in writing that corporal punishment may not be used on the student. Requires that a parent or guardian be provided with a form to make the election regarding the use of corporal punishment either (1) at the start of the school year, (2) when the student first enters school for that year, or (3) at the first IEP or Section 504 plan meeting during the school year. Directs local boards of education to make an annual report to the State Board of Education on the number of times that corporal punishment was administered. Requires that the report comply with the federal Family Educational Rights and Privacy Act, 20 U.S.C. § 1232g and specifies the data that the report must include. Makes conforming changes to the title.

Applies beginning with the 2010-11 school year.

**H 1721. H.E.L.P. SMALL BUSINESS ACT.** Filed 5/13/10. House committee substitute makes the following changes to 2nd edition. Changes the term to *full-time jobs* (was, *full-time employees*) for the small business tax credit calculation provision in proposed GS 105-129.16J. Makes technical change.

**H 1682. CORP. PUNISH. AND CHILDREN W/DISABILIT.** Filed 5/12/10. House committee substitute makes the following changes to 2nd edition.

Adds the following reporting requirements to the corporal punishment report filed annually by each local board of education under proposed subsection (a1) in GS 115C-391: (1) the race and ethnicity of the students who received corporal punishment (was, race only) and (2) the reason for the administration of the corporal punishment for each student who received it.

Makes technical changes.

**SL 2010-159 (H 1682). CORPORAL PUNISHMENT AND CHILDREN WITH DISABILITIES.** *AN ACT TO PROHIBIT THE USE OF CORPORAL PUNISHMENT ON A STUDENT WITH A DISABILITY AS DEFINED IN G.S. 115C-106.3(1) OR SECTION 504 OF THE FEDERAL REHABILITATION ACT OF 1973 WHOSE PARENT OR GUARDIAN HAS STATED IN WRITING THAT CORPORAL PUNISHMENT SHALL NOT BE ADMINISTERED ON THAT STUDENT, AND TO REQUIRE LOCAL BOARDS OF EDUCATION TO REPORT OCCURRENCES OF CORPORAL PUNISHMENT TO THE STATE BOARD OF EDUCATION.* Summarized in *Daily Bulletin* 5/12/10, 5/25/10, and 6/9/10. Enacted July 23, 2010. Effective July 23, 2010.
