H 1685. TURNPIKE AUTHORITY TOLL ENFORCEMENT CHANGES. Filed 5/12/10. TO MAKE VARIOUS CHANGES TO THE STATUTES GOVERNING COLLECTION AND ENFORCEMENT OF TOLLS BY THE NORTH CAROLINA TURNPIKE AUTHORITY.

Amends GS 136-89.211 to remove the 35% limitation on the discount that the Turnpike Authority (Authority) may provide to vehicles with an electronic toll collection transponder. Extends the discount to motor vehicles that have prepaid the toll. Amends GS 136-89.214(a) to require that motor vehicles pay the toll prior to travel or at the time of travel on a turnpike project with an open road tolling system (was, a 15 day grace period to pay the toll after travel occurred). Amends GS 136-89.215 to require that a person who receives an unpaid toll bill take action within 30 days after the Authority sent the invoice (was, 30 days after receiving the bill). Amends GS 136-89.216 to subject persons to a \$25 penalty if the individual receives two or more unpaid toll bills (was, one unpaid toll bill) and does not pay within 30 days. Removes six-month period distinction for billing purposes. Amends GS 136-89.217 to remove the remedial provision allowing payment to the Division of Motor Vehicles of all unpaid tolls and other penalties if an individual's motor vehicle registration renewal is blocked by the Commissioner of Motor Vehicles. Makes other conforming changes. Effective for offenses committed on or after December 1, 2010. Intro. by Cole.

H 1685. TURNPIKE AUTHORITY TOLL ENFORCEMENT CHANGES. Filed 5/12/10. House committee substitute makes the following changes to 1st edition. Repeals GS 136-82.2 (state toll bridges). Adds language to GS 136-89.216, specifying that only one penalty may be assessed in a six-month period, beginning from the date the toll was incurred (did not previously include start date). Makes technical changes.

H 1685. TURNPIKE AUTHORITY TOLL ENFORCEMENT CHANGES. Filed 5/12/10. Senate committee substitute makes the following changes to 2nd edition. Amends GS 136-89.216 to provide that only one penalty for the failure to pay an open road toll may be assessed in a sixmonth period (was, assessed in a six-month period beginning from the date the toll was incurred).
