**H 170. SECRETARY OF STATE NOTIFY ELECTORS.** Filed 2/17/09. *TO PROVIDE THAT THE SECRETARY OF STATE SHALL NOTIFY PARTIES AND ELECTORS OF THE DUAL-OFFICE HOLDING RULE, AND TO ALLOW PRESIDENTIAL ELECTORS TO HOLD THAT OFFICE IN ADDITION TO THE NUMBER OF APPOINTIVE OFFICES ALLOWED BY LAW.*

Enacts a new GS 163-209.2 to provide that the office of elector may be held in addition to the maximum number of appointive offices allowed by GS 128-1.1.

Amends GS 163-209 to require that the Secretary of State (Secretary), upon receiving the filing of a candidate's name for the office of elector, notify the candidate of the state constitutional and statutory dual-office holding requirements, including that an elector vacates another elective office if it is held at the time of taking the oath of office as elector. Makes conforming changes. Enacts a new GS 163-209.1 to require that the Secretary, during January of each year in which electors are elected, notify each political party authorized to nominate electors of the state constitutional and statutory dual-office holding requirements, including that an elector vacates another elective office if it is held at the time of taking the oath of office as elector.
