H 1814. CATAWBA ENERGY EFFICIENCY/RENEWABLE. Filed 5/18/10. EXEMPTING CATAWBA COUNTY FROM COMPETITIVE BIDDING REQUIREMENTS WHEN LETTING CONTRACTS AUTHORIZED BY ITS BOARD OF COMMISSIONERS TO INCREASE ENERGY EFFICIENCY, AND TO AUTHORIZE THAT COUNTY TO ENTER INTO LEASES FOR THE SITING AND OPERATION OF RENEWABLE ENERGY FACILITIES FOR TWENTY YEARS WITHOUT TREATING IT AS A SALE AND WITHOUT GIVING NOTICE BY PUBLICATION.

Authorizes Catawba County to contract for apparatus, supplies, materials, or equipment that will be used as part of any energy efficiency program authorized by its board of commissioners without having to comply with the requirements of GS 143-129, GS 143-131, and GS 143-132. Amends Section 3 of SL 2009-149 (Raleigh Energy Efficiency) to make that law applicable to Catawba County.

H 1814. CATAWBA ENERGY EFFICIENCY/RENEWABLE. Filed 5/18/10. House amendment makes the following changes to 1st edition.

Provides two alternatives for amending Section 3 of SL 2009-149, depending on whether Senate Bill 1114, 2009 Regular Session, becomes law or not. Both alternatives exempt Catawba County from competitive bidding requirements when granting authorized contracts aimed at increasing energy efficiency, and authorize Catawba County to enter into leases for the siting and operation of renewable energy facilities for 20 years without treating it as a sale and without giving notice by publication.
