H 1824. COYOTE CONTROLS. Filed 5/18/10. *TO PROVIDE AN ADDITIONAL METHOD OF TRAPPING COYOTES AND TO INCREASE THE AVAILABILITY OF DEPREDATION PERMITS FOR COYOTES TO LIVESTOCK AND POULTRY OWNERS AS RECOMMENDED BY THE HOUSE SELECT COMMITTEE ON COYOTE NUISANCE REMOVAL.*

Amends GS 113-274(c)(1a) to provide that livestock or poultry owners are to be issued depredation permits for coyotes on request. Amends GS 113-291.6 to provide that a holder of a depredation permit for coyotes may use a Collarum trap or similar approved trap for taking coyotes. The trap must be attended daily and any animals caught other than coyotes must be released. Requires the Wildlife Resource Commission to adopt rules implementing these provisions by December 1, 2010.

H 1824. COYOTE CONTROLS. Filed 5/18/10. House committee substitute makes the following changes to 1st edition. Amends proposed GS 113-291.6(h) to add that a person authorized to use the Collarum trap, or similar trap, under the depredation permit must be required to provide the Wildlife Resources Commission with information on the effectiveness and efficiency of the trap.

H 1824. COYOTE CONTROLS. Filed 5/18/10. House committee substitute makes the following changes to 2nd edition.

Amends proposed GS 113-291.6(h) to direct a person, authorized to use described traps pursuant to the subsection (was, under the depredation permit), to provide information on the effectiveness and efficiency of the traps as requested by the Wildlife Resources Commission (Commission) (was, in accordance with Commission rules). Changes the effective date of the proposed subsection to October 1, 2010 (was, effective when the act becomes law).

Requires the Commission to adopt rules to implement the proposed subsection on or before October 1, 2010 (was, December 1, 2010).
