H 218. PARENT & STUDENT EDUCATIONAL INVOLVEMENT ACT. Filed 2/18/09. *TO ENACT THE PARENT AND STUDENT EDUCATIONAL INVOLVEMENT ACT.*

Amends GS 115C-391(d5) to require that *written* notice be sent to a student's parent, guardian, caregiver, or other person legally responsible for the child (referred to hereinafter as the parent) when a student is recommended for expulsion or suspension (was, is expelled or suspended) for more than 10 days (*long-term suspension*). Requires that written notice be provided to the student's parent by the end of the workday during which the suspension or expulsion is recommended when reasonably possible, but in any case no later than the end of the following workday. Sets forth the information to be included in the written notice, including a description of the incident, specific provisions of the policy or rule allegedly violated, hearing procedures if suspension or expulsion is contested, the right to an attorney and options regarding using an advocate for representation, and the right of the parent to review the student's educational records prior to the hearing. Makes technical changes. Effective beginning with the 2009-10 school year.

H 218. PARENT & STUDENT EDUCATIONAL INVOLVEMENT ACT. Filed 2/18/09. House committee substitute makes the following changes to 2nd edition. Specifies that a notice is required to be given to the parent of a student that has been suspended *for more than 10 days* by the end of the workday during which the suspension is recommended, when reasonably possible, but in no event later than the end of the following workday. Removes the provision defining suspension of more than 10 days as *long term suspension* and refers to suspension as suspension for more than 10 days throughout the act. Makes conforming and technical changes. Changes the title to *AN ACT TO MODIFY THE REQUIREMENTS FOR THE NOTICE THAT MUST BE GIVEN TO A PARENT WHEN A STUDENT IS RECOMMENDED FOR A SUSPENSION OF MORE THAN TEN DAYS OR AN EXPULSION FROM SCHOOL.*
