H 622. EXTEND LOUISBURG EXEMPTN FOR COMPETITIVE BIDS. Filed 3/16/09. *TO EXTEND THE EXEMPTION FOR THE TOWN OF LOUISBURG FROM THE COMPETITIVE BIDDING REQUIREMENTS FOR THE LOUISBURG ECONOMIC DEVELOPMENT PROJECT.*

Amends Section 4 of SL 2007-216 as title indicates. Sets the new expiration date as January 1, 2011 (was, January 1, 2009).

H 622. EXTEND LOUISBURG AND ONSLOW EXEMPTIONS (NEW). Filed 3/16/09. Senate committee substitute makes the following changes to 1st edition. Provides that, notwithstanding any expiration dates to the contrary, there be an extension for the Onslow County Administrative Complex to permit under the 2006 State Building Codes (Building, Energy Conservation, Fire, Fuel Gas, Mechanical, and Plumbing) until August 1, 2009, at which time the applicable Code must apply.

Makes a conforming change to the title.

H 622. EXTEND LOUISBURG AND ONSLOW EXEMPTIONS. Filed 3/16/09. Senate amendment makes the following changes to 2nd edition. Deletes Section 2 of the act, which provided for an extension for the Onslow County Administrative Complex to permit under the 2006 State Building Codes (Building, Energy Conservation, Fire, Fuel Gas, Mechanical, and Plumbing) until August 1, 2009. Makes a conforming change to the title.

H 622. EXTEND LOUISBURG AND ONSLOW EXEMPTIONS. Filed 3/16/09. Senate amendment makes the following changes to 3rd edition. Provides that the provisions of Article 8 of GS Chapter 143 (Public Contracts) do not apply to a facility for public recreation, senior activities, and other public uses to be built by Currituck County.
