H 683. ADOPT NC HOT SAUCE DAY. Filed 3/18/09. *ESTABLISHING NORTH CAROLINA HOT SAUCE DAY.*

Enacts new GS 103-12 to designate the second Saturday of September of each year as North Carolina Hot Sauce Day.

H 683. PREPAID WIRELESS SUNSET/PERMIT EXTENSIONS (NEW). Filed 3/18/09. Senate committee substitute deletes all provisions of 1st edition and replaces it with *AN ACT EXTENDING THE SUNSET ON THE COLLECTION OF SERVICE CHARGES FOR PREPAID WIRELESS TELEPHONE SERVICES; AND TO AMEND THE PERMIT EXTENSIONS ACT OF 2009.*

Amends Section 7(c) of SL 2007-383, as amended, to exempt prepaid wireless telephone service for the 2008, 2009, 2010, and 2011 calendar years (was, through 2010) from 911 service charges imposed under GS 62A-43.

Amends Section 4 of SL 2009-406 to extend the suspension period for the running of the period of development approval and any associated vested right from January 1, 2008, through December 31, 2012 (was, December 31, 2010) for applicable development approvals, under the Permit Extensions Act of 2009.

H 683. PREPAID WIRELESS SUNSET/PERMIT EXTENSIONS. Filed 3/18/09. Senate amendment makes the following changes to 2nd edition.

Provides that Section 5 of SL 2009-406 (the Permit Extension Act of 2009), as amended, applies to the provisions of this act.

Amends Subdivision 3 of Section 5.2(b) of SL 2009-406, as enacted by Section 2 of SL 2009-572, regarding a development approval contingent upon a water supply system or a sanitary sewer system connection, to allow a local government to reallocate reserved capacity for suspended projects if among the designated requirements it does not reallocate capacity to exceed the amount of the requested capacity (was, reserved capacity).

Rewrites Subdivision 1 of Section 3 of SL 2009-406 to amend the definition for *development approval* to apply to approvals that are for the development of land or for the provision of water or wastewater services *including water and wastewater service capacity allocations*.

Provides that SL 2009-406 as amended is not to be interpreted or applied (1) to modify any person's obligations or (2) to impair the rights of any party under any contract, including any bond or other similar undertaking.

Renumbers the sections of the act accordingly.

July 10, 2010

H 683. PERMIT EXTENSIONS (NEW). Filed 3/18/09. Conference report recommends the following changes to 3rd edition to reconcile matters in controversy.

Deletes the provisions extending the sunset on the collection of service charges for prepaid wireless telephone service.

Amends SL 2009-406, as amended, (Permit Extension Act of 2009), to extend the suspension of the running of the period of the development approval and any associated vested right under GS 153A-344.1 or GS 160A-385.1 until December 31, 2011 (was, December 31, 2012 in previous edition), for any development approval that is current and valid at any point beginning January 1, 2008 and ending December 31, 2010.

Adds a new section 4.1 allowing a local government to provide by resolution that SL 2009-406, as amended, does not apply to a development approval issued by that local government. Provides for the expiration of such an approval.

Provides that act is not to be construed or implemented to authorize charging a water or wastewater tap fee that has been previously paid in full for a project subject to development approval.

Provides conditions for qualifying for development approval extension under SL 209-406, as amended. Also provides that failure to comply with any condition in the act may result in the termination of the extension of the development approval and provides for a right of appeal of a termination of an extension of a development approval.

SL 2010-177 (H 683). PERMIT EXTENSIONS. AN ACT TO AMEND THE PERMIT EXTENSION ACT OF 2009. Summarized in *Daily Bulletin* 6/15/10, 6/23/10, and 7/10/10. Enacted August 2, 2010. Effective August 2, 2010.
