H 752. ANNUAL REGISTRATION OF FARM VEHICLES (=S 690). Filed 3/23/09. *TO PROVIDE APPLICANTS WHO REGISTER MOTOR VEHICLES AT THE FARMER RATE TO CHOOSE BETWEEN A STAGGERED REGISTRATION YEAR OR AN ANNUAL REGISTRATION YEAR.*

Identical to S 690, filed 3/19/09.

H 752. LOBBYING LATE FEES (NEW). Filed 3/23/09. Senate committee substitute deletes all provisions of the 1st edition and replaces it with *AN ACT TO REQUIRE NOTICE BE GIVEN PRIOR TO ASSESSING A LATE FILING FEE FOR LOBBYISTS AND LOBBYIST PRINCIPALS.* Amends GS 120C-401(e) to require that the notice given to a lobbyist who has not filed a report when required be made through certified letter, return receipt requested. Creates a late filing fee of \$50 per day beginning on the tenth day after the certified letter is received by the lobbyist, with a maximum cumulative fee of \$500. Effective October 1, 2009.

H 752. LOBBYING LATE FEES. Filed 3/23/09. Senate amendment makes the following changes to 2nd edition. Enacts new GS 131E-191.1 to prohibit a person (1) registered as a lobbyist from being appointed to or serving on the NC State Health Coordinating Council (Council) and (2) previously registered as a lobbyist to be appointed to or serving on the Council within 120 days after the expiration of the lobbyist's registration. Effective when the act becomes law.

Changes the title to *AN ACT TO REQUIRE NOTICE BE GIVEN PRIOR TO ASSESSING A LATE FILING FEE FOR LOBBYISTS PRINCIPALS, AND TO PROHIBIT LOBBYISTS FROM SERVING ON THE NORTH CAROLINA STATE HEALTH COORDINATING COUNCIL.*

SL 2009-477 (H 752). LOBBYING LATE FEES. *AN ACT TO REQUIRE NOTICE BE GIVEN PRIOR TO ASSESSING A LATE FILING FEE FOR LOBBYISTS AND LOBBYIST PRINCIPALS, AND TO PROHIBIT LOBBYISTS FROM SERVING ON THE NORTH CAROLINA STATE HEALTH COORDINATING COUNCIL.* Summarized in *Daily Bulletin* 3/23/09, 8/5/09, and 8/6/09. Enacted August 26, 2009. Section 1 is effective October 1, 2009. The remainder is effective August 26, 2009.
