H 772. HUNTERSVILLE/NEWSPAPER ADVERTISING. Filed 3/24/09. *TO REDEFINE THE NEWSPAPERS ELIGIBLE TO ACCEPT LEGAL ADVERTISING IN THE TOWN OF HUNTERSVILLE.*

Amends GS 1-597 to authorize the town of Huntersville to publish legal notices in a newspaper that is admitted to the mails as “standard” rather than “periodical” matter, if the newspaper otherwise satisfies the existing requirements and (i) maintains an office in the county or political subdivision where publication is required, (ii) is published for the purpose of disseminating information of a public character, (iii) is not primarily designed for advertising purposes, and (iv) does not contain more than 75% advertising in more than one-fourth of the issues published during the preceding six-month period.

H 772. HUNTERSVILLE CHARTER REWRITE (NEW). Filed 3/25/09. House committee substitute makes the following changes to 1st edition. Deletes the provisions of the first edition and replaces them with *AN ACT TO REVISE AND CONSOLIDATE THE CHARTER OF THE TOWN OF HUNTERSVILLE*. Provides for election of mayor for a two-year term and election of a six-member town board elected at large for two-year terms on plurality basis in nonpartisan elections beginning in 2011. Also provides for election of mayor pro tem by town board, compensation of mayor and board; filling of vacancies; appointment of manager, clerk, attorney, finance director, and tax collector, use of design-build method for public contracts; disposition of property; ordinances concerning impact of development on services; and satellite annexation.

H 772. HUNTERSVILLE CHARTER REWRITE. Filed 3/24/09. House committee substitute makes the following changes to 2nd edition. Specifies, in Section 2 of the act, acts or portions of acts that have been consolidated into the act and repealed. Also makes technical changes.

H 772. HUNTERSVILLE CHARTER REWRITE. Filed 3/24/09. House amendment makes the following changes to 3rd edition. Deletes Chapter 87, Private Laws of 1929, from the list of acts or portions of acts, which having served their purpose or having been consolidated into this act, are repealed.
