Filed 3/30/09. *TO ALLOW THE DIVISION TO REFUSE TO REGISTER A VEHICLE IF THE VEHICLE IS NOT IN COMPLIANCE WITH THE INSPECTIONS REQUIREMENTS, TO CREATE A TEN-DAY WINDOW FOR INSPECTING NEW AND USED VEHICLES REGISTERED IN THIS STATE, TO REQUIRE PROOF OF FINANCIAL RESPONSIBILITY FOR A THREE-DAY TRIP PERMIT, AND TO MAKE TECHNICAL CHANGES TO THE INSPECTION PROGRAM STATUTES.* Identical to S 826, filed 3/24/09.

H 882. MOTOR VEHICLE INSPECTION PROGRAM CHANGES. Filed 3/30/09. House committee substitute makes the following changes to 1st edition. Changes the title to *AN ACT TO ALLOW THE DIVISION OF MOTOR VEHICLES TO REFUSE TO REGISTER A VEHICLE IF THE VEHICLE IS NOT IN COMPLIANCE WITH THE INSPECTIONS REQUIREMENTS, TO REQUIRE PROOF OF FINANCIAL RESPONSIBILITY FOR A THREE-DAY TRIP PERMIT, AND TO MAKE TECHNICAL CHANGES TO THE INSPECTION PROGRAM STATUTES.* Reverses the amendments made to GS 20-183.4C(a)(4) and (a)(5) in the 1st edition regarding when a new or used vehicle acquired by an NC resident from outside of NC must be inspected and when a vehicle owned by a new resident of NC must be inspected, providing that such vehicles must be inspected before being registered with the Division of Motor Vehicles (1st edition provided that such vehicles must be inspected within 10 days after the vehicle is registered).

H 882. MOTOR VEHICLE INSPECTION PROGRAM CHANGES. Filed 3/30/09. House amendment makes the following changes to 2nd edition. Makes technical changes only.

H 882. MOTOR VEHICLE INSPECTION PROGRAM CHANGES. Filed 3/30/09. Senate committee substitute makes the following changes to 3rd edition. Adds provisions allowing the Commissioner of the Division of Motor Vehicles to waive vehicle inspection requirements for a single period of time not to exceed 12 months from the initial date of registration when a NC resident acquires a new or used vehicle from outside NC or when a new NC resident transfers the vehicle's registration from his or her former state to NC. Rewrites provisions regarding temporary exemption from inspection requirements so that they apply to vehicles that are principally garaged in NC and are primarily operated outside a county subject to emissions inspection requirements of outside of NC. Deletes proposed criminal penalty for a violation of DMV rules governing inspection program and, instead, adds new GS 20-183.8(b1) making the performance of a safety or emissions inspection without a license as required by GS 20-183.4 or GS 20-183.4A a Class 3 misdemeanor.
