H 921. LENOIR FOX TRAPPING. Filed 3/31/09. *TO ESTABLISH A SEASON FOR THE TRAPPING OF FOXES IN LENOIR COUNTY.*

Applicable to Lenoir County and effective when the act becomes law, establishes an open season with no bag limit for fox trapping with steel jaw or foothold traps from January 15 through February 28 of each year.

H 921. LENOIR/JOHNSTON TAKING OF FOXES (NEW). Filed 3/31/09. House committee substitute makes the following changes to 1st edition. Adds provision, applying only to Lenoir County, requiring Wildlife Resources Commission to provide for the sale of foxes taken lawfully in Lenoir County.

Amends SL 2007-47, Section 1, to provide that there is an open season in Johnston County for taking foxes with weapons and by trapping during the season set by the Wildlife Resources Commission each year (was, from December 1 through February 20 of each year). Applies only to Johnston County.

H 921. WASHINGTON DEANNEXATION/DARE TRAPPING (NEW). Filed 3/31/09. Senate committee substitute makes the following changes to 2nd edition. Deletes the contents of the 2nd edition and replaces it with *AN ACT TO AMEND THE TRAPPING LAWS OF DARE COUNTY AND TO REMOVE THE WARREN FIELD AIRPORT FROM THE CORPORATE LIMITS OF THE CITY OF WASHINGTON.* Amends Section 1 of SL 1985-178 (concerning trapping in Dare County) to prohibit the trapping of any game or furbearing animal except as provided by Wildlife Resources Commission rules (was, between March 1 and the later of January 2 or the last day of deer hunting season). Also makes it illegal to trap any game or furbearing animal with a trap that has a jaw spread exceeding seven and a half inches until after the later of January 2 or the last day of deer hunting season. Effective October 1, 2009.

Effective January 1, 2010, removes specified area from Washington's corporate limits. Provides that this does not affect the duty to pay taxes for any previous year or eliminate any tax liens for previous years.

SL 2009-469 (H 921). WASHINGTON DEANNEXATION/DARE TRAPPING. *AN ACT TO AMEND THE TRAPPING LAWS IN DARE COUNTY AND TO REMOVE THE WARREN FIELD AIRPORT FROM THE CORPORATE LIMITS OF THE CITY OF WASHINGTON.* Summarized in *Daily Bulletin* 7/28/09. Enacted August 11, 2009. Section 2 is effective January 1, 2010. The remainder is effective October 1, 2009.
