H 96. LOCAL GOVERNMENT SURPLUS PROPERTY DONATIONS. Filed 2/9/09. *CLARIFYING THE AUTHORITY OF COUNTIES TO DONATE SURPLUS, OBSOLETE OR UNUSED PERSONAL PROPERTY TO OTHER GOVERNMENTAL UNITS OR TO NONPROFIT ORGANIZATIONS.*

Amends GS 160A-280(a) to clarify that counties, in addition to cities, may donate to US governmental units, a sister city, or a nonprofit organization incorporated by the US or a state, including DC, any personal property, including supplies, materials, and equipment, that the governing board deems to be surplus, obsolete, or unused.

H 96. LOCAL GOVERNMENT SURPLUS PROPERTY DONATIONS. Filed 2/9/09. House committee substitute makes the following changes to 1st edition. Changes title to read: *TO AUTHORIZE CITIES AND COUNTIES TO DONATE SURPLUS, OBSOLETE, OR UNUSED PERSONAL PROPERTY TO CHARTER SCHOOLS AND TO MAKE A TECHNICAL CHANGE TO THE AUTHORITY OF CITIES AND COUNTIES TO DONATE SURPLUS, OBSOLETE, OR UNUSED PERSONAL PROPERTY TO OTHER GOVERNMENTAL UNITS OR TO NONPROFIT ORGANIZATIONS.* Amends the act, which had revised GS 160A-280(a) to authorize counties as well as cities to donate property to other governmental units, to authorize cities and local boards of education to do so. Also revises GS 160A-280(b) to define governmental units who may receive such property as including NC charter schools and makes a technical change to GS 160A-280(c) to limit its application to cities (was, cities, counties, and government units).

Amends GS 160A-280(a) to provide that a city (was, a city or a local board of education) may donate surplus, obsolete, or unused personal property to another governmental unit within the United States (US), a sister city, or a nonprofit organization incorporated in the US or one of its states, or the District of Columbia. Directs the governing board of the city (was, city or county) to post a public notice at least five days prior to the adoption of a resolution approving the donation. Changes the title to *AN ACT TO AUTHORIZE CITIES, COUNTIES AND LOCAL BOARDS OF EDUCATION TO DONATE SURPLUS, OBSOLETE, OR UNUSED PERSONAL PROPERTY TO CHARTER SCHOOLS AND TO MAKE TECHNICAL CHANGES TO THAT AUTHORITY.*
