S 1019. ESTABLISH NC FINANCIAL LITERACY COUNCIL. Filed 3/25/09. TO ESTABLISH A FINANCIAL LITERACY COUNCIL TO COORDINATE AND EXPAND THE STATEWIDE DELIVERY OF FINANCIAL EDUCATION FOR ALL NORTH CAROLINIANS.

Enacts new Article 8 (Financial Literacy Council) in GS Chapter 114 establishing the Council within the Department of Justice. The council consists of 18 members appointed by the Governor from various entities and departments, with 3-year terms. Administrative and staff support shall be provided by the Department of Justice and the Council shall meet at least quarterly. Enacts GS 114-54 specifying the Council's duties and GS 114-55 providing that upon request, all state officers, agents, agencies, and departments are required to provide information and data to the Council.

S 1019. ESTABLISH NC FINANCIAL LITERACY COUNCIL. Filed 3/25/09. Senate amendment makes the following changes to 1st edition.

Amends the caption to proposed GS 114-51 to read, "Membership; terms; quorum, (was, Membership; terms). Provides that a majority of the NC Financial Literacy Council's (Council) members constitute a quorum. Expands the data and information that state entities are to furnish to the Council upon request to include all information and data pertinent to financial education activities.

S 1019. ESTABLISH NC FINANCIAL LITERACY COUNCIL. Filed 3/25/09. House committee substitute makes the following changes to 2nd edition. Specifies in proposed GS 114-53 (was, GS 114-54 in the previous edition) that the Financial Literacy Council (Council) must consider and make recommendations to address unique financial issues facing students in higher education and how to address those issues through community colleges and public and private university systems. Also clarifies that the Council must use talents, expertise, and resources of the public and private university systems (was, the State university system), to further its mission. Adds a provision to allow public members of the Council to receive subsistence and travel expenses. Makes various technical, clarifying, and organizational changes to proposed Article 8 of GS Chapter 114.
