**S 1076. MODIFY CRIM. JUSTICE PARTNERSHIP PROGRAM.** Filed 3/26/09. *TO MODIFY THE CRIMINAL JUSTICE PARTNERSHIP PROGRAM TO ALLOW COMMUNITY-LEVEL OFFENDERS TO BE SERVED BY THE PROGRAM.*

Amends GS 143B-273.4 to allow offenders sentenced to community punishment under structured sentencing to be eligible for programs funded by the Criminal Justice Partnership Program. Effective July 1, 2009.

**S 1076. MODIFY CRIM. JUSTICE PARTNERSHIP PROGRAM.** Filed 3/26/09. Senate committee substitute makes the following changes to 1st edition. Changes the effective date from July 1, 2009, to December 1, 2009.

**S 1076. MODIFY CRIM. JUSTICE PARTNERSHIP PROGRAM.** Filed 3/26/09. House committee substitute makes the following changes to 2nd edition. Amends GS 143B-273.4 to modify the eligibility requirements for the Criminal Justice Partnership Program (Program) to provide that offenders sentenced to community punishment are eligible for the Program if the Division of Community Corrections determines that the offender would benefit from program participation, based upon the results of a risk assessment. Makes organizational and clarifying changes to the act and amends the title to more accurately reflect the content.

**S 1076. MODIFY CRIM. JUSTICE PARTNERSHIP PROGRAM.** Filed 3/26/09. House committee substitute makes the following changes to 3rd edition. Amends GS 143B-273.14(a) to provide that the listed fundable programs in subdivision (1) are for offenders who receive *community or* intermediate punishments.

**S 1076. MODIFY CRIM. JUSTICE PARTNERSHIP PROGRAM.** Filed 3/26/09. House amendment makes the following changes to 4th edition. Current law directs the Department of Correction to report annually by February 1 on the status of the Criminal Justice Partnership Program to various legislative committees and subcommittees. Amends GS 143B-273.8(b) to require that the following information also be included in that report: (1) details of personnel, travel, contractual, operating, and equipment expenditures for each program type; and (2) an explanation of the variance for counties whose expenditures deviate proportionally from the average percentage expenditure for each program type.
