S 1083. LITTLE TENNESSEE RIVER BASIN ADVISORY COMM. Filed 3/26/09. TO ESTABLISH THE LITTLE TENNESSEE RIVER BASIN ADVISORY COMMISSION.

Adds new Part 2 to Article 8 of GS Chapter 77, creating commission listed in title. Commission is to consist of representatives from three states (Tennessee, NC, and Georgia). Commission to be funded from appropriations from each state. Specifies composition of Commission (26 members, total, coming from the three states, with a variety of appointing authorities). The purpose of the Commission is to provide advice to federal, state, and local government on the management and stewardship of the Little Tennessee River Basin. Directs the Department of Environment and Natural Resources to provide NC's portion of the staff, and authorizes the Commission to raise funds and seek grants. Requires annual reports to specified governmental entities in each state, with the first one due by October 1, 2011. Provides for termination of the Commission upon legislative action by any one of the member states. Makes conforming changes to GS 77-110, GS 77-111, and GS 77-118.
