**S 116. STOWE BOTANICAL GARDENS SPECIAL PLATE.** Filed 2/10/09. TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO PRODUCE A DANIEL STOWE BOTANICAL GARDEN SPECIAL REGISTRATION PLATE FOR THE DANIEL STOWE BOTANICAL GARDEN FOUNDATION, INC.

Amends GS 20-79.4(b) to add a special registration plate that bears the phrase "Daniel Stowe Botanical Garden" and includes a logo designed by the Daniel Stowe Botanical Garden Foundation, Inc. (Garden Foundation). Amends GS 20-79.7 to establish a special plate fee of \$30. Distributes \$10 of the fee amount to the Special Registration Plate Account and \$20 to the Collegiate and Cultural Attraction Plate Account (CCAPA). Amends GS 20-81.12 to direct the Division of Motor Vehicles to make a quarterly transfer of the money in the CCAPA earned from the sale of the Daniel Stowe plates to the Garden Foundation to provide funding for the Daniel Stowe Botanical Garden outreach program. Provides that the development of the plate is contingent on receiving at least 300 plate applications. Amends GS 20-63(b) to include the plate in those that are not required to be "First in Flight" plates. Effective July 1, 2009.

S 116. AUTHORIZE VARIOUS SPECIAL PLATES (NEW). Filed 2/10/09. Senate committee substitute makes the following changes to 1st edition. Changes title to AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO ISSUE VARIOUS SPECIAL REGISTRATION PLATES. Amends GS 20-79.4(b) to provide for issuance of the following types of special registration plates (in addition to the Daniel Stowe Botanical Garden plate in the 1st edition). contingent upon the receipt of at least 300 applications for the particular plate: Armed Forces Expeditionary Medal Recipient; Boy Scouts of America; Carolinas Golf Association; First in Turf; Girl Scouts: High Point Furniture Market 100th Anniversary: Home of American Golf: Javcees: Mayor; Municipal Council; NC Horse Council; NC Wildlife Federation; North Carolina Master Gardener; P.E.O. Sisterhood; Phi Beta Sigma Fraternity; School Board; S.T.A.R.; Support NC Education: Support Soccer: Town of Oak Island: and Travel and Tourism. Amends GS 20-79.7(a) to establish a plate fee of \$30 for the following plates: Boy Scouts of America; Carolinas Golf Association; Girl Scouts; Home of American Golf; P.E.O. Sisterhood; S.T.A.R.; Support NC Education; and Travel and Tourism. Establishes a \$25 fee for First in Turf and Support Soccer plates and a \$20 fee for Jaycees, NC Horse Council, NC Wildlife Federation, North Carolina Master Gardener, and Phi Beta Sigma Fraternity plates. Amends GS 20-79.7(b) and GS 20-81.12 to specify allocation of fees received for specific plates. Deletes amendments to GS 20-63(b) in 1st edition. Changes the effective date to when the act becomes law (was, July 1, 2009).

**S 116. AUTHORIZE VARIOUS SPECIAL PLATES.** Filed 2/10/09. Senate amendments make the following changes to 2nd edition. Amendment #1 amends GS 20-79.4(b) to add a special registration plate issuable to a retired Piedmont Airlines employee who presents to the Division of Motor Vehicles (DMV), along with the plate application, a copy of the employee's letter of retirement. Provides that the plate bear the phrase "PA," and include the Piedmont Speed Bird logo. Amends GS 20-79.7 to establish a special plate fee of \$20. Distributes \$10 of the fee amount to the Special Registration Plate Account (SRPA) and \$10 to the Collegiate and Cultural Attraction Plate Account (CCAPA). Amends GS 20-81.12 to direct the DMV to make a quarterly transfer of the money in the CCAPA earned from the sale of Retired Piedmont Airlines Employee plates to Piedmont Silver Eagles Charitable Funds, Inc., to be used for scholarships and family assistance for retired Piedmont Airlines employees and their families. Provides that the development of the plate is contingent on receiving at least 300 plate applications.

Amends GS 20-79.4(130) to rename the US Navy Specialty plate as the US Navy Submarine Veteran plate. Provides that the renamed plate is issuable to a veteran of the United States Navy Submarine Service (was, issuable to a veteran of the United States Navy Submariner Service). Provides that the plate bear the phrase "United States Navy Submarine Veteran (was, Silent Service Veteran)," and include a representation of the Submarine Service

Qualification insignia overlaid upon a representation of the State of North Carolina (was, bear a representation of the Submarine Service Qualification pin). Provides that the DMV may not issue the plate authorized by this subdivision unless it receives at least 150 (was, 300) plate applications.

Act authorizes the DMV to issue special registration plates to the mayor of a municipality in the state and to a municipal council member, an alderman of a state municipality, or a commissioner in this state. Amendment #2 provides that the number of a municipality placed on such specialty plates must be determined by the order of the municipality in an alphabetical list of municipalities that assigns number one to the first municipality in the list, except that municipalities incorporated with an effective date after July 1, 2009, must be placed at the end of the list in order of the date of incorporation.

Amends GS 20-81.12 to direct the Division of Motor Vehicles to make a quarterly transfer of the money in the CCAPA earned from the sale of NC Emergency Management plates to the NC Emergency Management Association to be used for training and education purposes. Provides that the development of the plate is contingent on receiving at least 300 plate applications.
