S 1248. EARLY IDENTIF. & INTERV. FOR AT-RISK STUDENTS (=H 1875). Filed 5/19/10. *TO REQUIRE LOCAL SCHOOL ADMINISTRATIVE UNITS TO IDENTIFY STUDENTS AT RISK OF ACADEMIC FAILURE AND NOT SUCCESSFULLY PROGRESSING TOWARD GRADUATION NO LATER THAN THE FOURTH GRADE AND TO PROVIDE PERSONAL EDUCATION PLANS FOR THOSE STUDENTS, AND TO REQUIRE LOCAL SCHOOL ADMINISTRATIVE UNITS TO REPORT ANNUALLY TO THE STATE BOARD OF EDUCATION ON THE STRATEGIES AND SUCCESS OF FOCUSED INTERVENTION FOR THOSE STUDENTS, AS RECOMMENDED BY THE JOINT LEGISLATIVE COMMISSION ON DROPOUT PREVENTION AND HIGH SCHOOL GRADUATION.*

S 1248. EARLY IDENTIF. & INTERV. FOR AT-RISK STUDENTS. Filed 5/19/10. Senate committee substitute makes the following changes to 1st edition.

Amends GS 115C-105.41 to delete the provision requiring local school administrative units (LEAs) to make an annual report to the State Board of Education on the progress of identified students and replaces it with a provision that LEAs must submit an annual certification to the SBE affirming that they have complied with the requirements of the statute regarding the generating of personal education plans for students at-risk of academic failure.

S 1248. EARLY IDENTIF. & INTERV. FOR AT-RISK STUDENTS. Filed 5/19/10. Senate amendment makes the following changes to 2nd edition. Amends GS 115C-105.41 (students placed at risk of academic failure; personal education plans) to require the State Board of Education to periodically review data on the progress of identified students and report to the Joint Legislative Oversight Committee. Makes conforming and clarifying changes to the title.
