**S 256. CLARIFY LOCAL GOVERNMENT EVACUATION AUTHORITY.** Filed 2/19/09. *TO CLARIFY THAT COUNTIES AND CITIES HAVE THE AUTHORITY TO ORDER EVACUATIONS IN CERTAIN SITUATIONS, AS RECOMMENDED BY THE JOINT SELECT COMMITTEE ON EMERGENCY PREPAREDNESS AND DISASTER MANAGEMENT RECOVERY.*

Amends GS 14-288.12(b) to grant municipalities the power to enact by ordinance, when dealing with a state of emergency, a prohibition or restriction that (1) directs or compels evacuation of all or part of the population from any stricken or threatened area within the governing body's jurisdiction; (2) prescribes routes, modes of transportation, and destinations in connection with evacuation; and (3) controls ingress and egress of a disaster area, the movement within the area, and the occupancy of premises therein. Makes a technical change to GS 166A-14(a).
